

## **Privacy Policy**

This Privacy Notice outlines how we safeguard your data, collect, use, store, and protect your personal information when you access our website and materials, engage in our email communications, register for our coaching programs, download free resources, or purchase our digital products. By using our services, you agree to the practices described in this Privacy Notice.

### **Overview**

### **Information We Collect**

We collect information from you in the following ways:

- **Personal Information:** When you sign up for our coaching programs, download free resources, or purchase digital products, we may ask for personal details such as your name, email address, phone number, contact information, and billing information.
- **Information related to your participation in the programs and courses** (progress, feedback, assessments)

- **Payment Information:** If you make a purchase, we collect billing information, including your payment method details, processed by third-party payment processors (such as PayPal, Stripe). Payment details are securely processed via third-party platforms like Stripe or PayPal.
- **Usage Data:** We may collect information about your interaction with our website, such as IP addresses, browser type, device information, pages visited, and other analytical data to improve our services.
- **Cookies and Tracking:** We use cookies to enhance your experience on our website. You can disable cookies in your browser settings, but this may affect your ability to use some features of our site.
