Auction Dates and Locations:

Bidding begins and closes as depicted on the Mobile bidding platform/website (bid.blackbeltauctions.com). At the specified auction start time lots will begin closing sequentially. Each auction varies - However the staggered close time is usually between 45sec and 1min. This is an Online-Only Auction. Bidding will begin closing on each auction at the times specified. Inspection Dates & Times:

Buyers are always encouraged to inspect items in person prior to bidding to make their own determinations as to condition, age, size, authenticity, value and any other determining factor by appointment only. Bidders who forego the opportunity to inspect and preview items understand and acknowledge that this affects their ability to accurately judge its condition and value.

Items can be made available for inspection up to 48 hours prior to the start of the close of the sale, by appointment ONLY, at our Cochranville PA. Please call 484-746-3200, ext 2 to schedule an appointment. A limited number of inspection appointments are available for each auction event, and will be confirmed on a first-call, first served basis. Not all inventory will be open for previews.

Bidding:

To bid in our Online-Only Auction you must first register to receive a username and password using a valid and active e-mail account. To register, please visit our website bid.blackbeltauctions.com register, or download mobile app, click the drawer, click login, click Create Account.

When approved for a username and password you will be notified by E-mail and asked to verify your E-mail account by clicking the verify button or the link provided in the notification E-mail. Once registered, you may use this name and password for all future BBA Online- Only Auctions, and can begin updating your profile with your Phone number, address, credit card information, etc. Debit/ Credit card information must be on file, in order to cast a bid. In some cases, the first time you save a new card to your account , there may be a “soft charge and void” to confirm there are funds available, similar to a gas station or a hotel. This soft charge falls off as a pending charge for most users within 10 Business days, depending on your financial intuition and merchant services provider. This occurs more frequently with debit cards. BBA does not receive these voided “soft charge” funds in any way. The bidder is required to update the debit/credit card information, including information about the expiry date, cancellation or loss of the card.

Once you have obtained your username and password, login each time you visit the website or mobile phone app to browse, view, and bid accordingly.

Each lot has a minimum starting bid, which must be placed in order for the them to sell. Reserve bids may be executed on cataloged lots on behalf of the Seller and shall be executed confidentially in a manner similar to the execution of absentee bids. All bids must follow BBA bid increment table. You may enter any bid amount you wish (rounded to the nearest dollar) as long as it meets or exceeds the requirement of the bid increment table for this action.

Buyer's Premium & Sales Tax:

PAYMENT TERMS:

If Bidder is certified as the Winning Bidder on a Lot by the Auctioneer, Bidder is contractually obligated to pay the Contract Price for that Lot (including the Hammer Price, Buyer's Premium and PA State Sales Tax); however, title and ownership of the Lot will not pass from Seller to Winning Bidder ("Buyer") until payment is made and clears & lot is picked up, or shipping is requested.

ALL PAYMENTS MUST BE MADE DIRECTLY TO BBA. Methods of payment accepted from all Buyers are: Credit Cards from Mastercard, Visa, Discover & American Express denominated in USD.

No personal or business checks will be accepted.

BBA will charge Buyers credit card on file for the full Purchase Contract Amount at the completion of the auction. In the event your card isn't charged immediately, it will be charged within 48 hours of the auction closing. Invoices that have cards-on-file decline may be subject to a \$15 declined card fee and lacking ongoing communications between Buyer and BBA, may result in Buyer being blocked from bidding on future BBA auctions. Failure to Pick-up or Arrange for the Delivery; Abandoned Property; Storage:

BBA uses a shipping and scheduling service called Shipping Saint. Following the close of the auction, BBA will begin to close out the sale. You will receive a email/text message from shipping saint to select Pick-up or Shipping. If you are picking up you will be directed to our scheduler to schedule your pick-up appointment. If shipping, you will be moved to our shipping department. Please be patient and there is no need to reach out to us at this point. We do promptly pack orders following a sale and you will receive an invoice directly through shipping saint to pay for your shipping. BBA requests all Buyers pickup or arrange shipping for their lots in a timely manner, in the respective manner outlined above. BBA offers a 14 day grace period to pick up items. Shipping and insurance costs are the responsibility of the Buyer and will be billed, again, through Shipping Saint. Any Buyer who requests their small lots to be shipped, will be billed a minimum of a \$5 handling fee per lot and the actual cost of shipping and insurance. BBA does not ship anything oversized, over 40 lbs, nor any furniture and reserves the right to refuse shipping on any item. In these cases, Buyer is responsible for signing a waiver of liability, and hiring their own shipping or transportation company to pickup the lot and arrange for packing and transport.

Transportation, storage, shipping, and handling fees start at \$5 per lot and are at the sole discretion of the Auctioneer.

Buyers located outside of the United States are responsible for any and all country specific duties, tariffs, taxes, and import fees associated with your purchase, including but not limited to VAT in Europe.

Any Buyers who have not picked up their item or arranged for shipping after 14 days, will be billed a storage fee of \$5 per lot, per day for up to an additional 14 days. BBA reserves the right to charge the Buyers credit card on file for storage fees for items not picked up in a timely manner, up to a maximum of 14 days and \$70. Auctioneer will have a possessory lien against such lot(s) that may be executed on in order to satisfy such storage charges. The auctioneer may commence an action against you for storage fees without executing on a storage lien. Twenty-nine (29) Days after the auction ended, BBA will re-list the item for sale.

By utilizing BBA and making a purchase therefore, you expressly agree that any lot purchased by you & paid for, that are not shipped or otherwise removed from the auction site within 29 days from close of the auction will be deemed abandoned to the auctioneer, unless otherwise stated. (E) Interpretation: No provision of this Contract shall be construed against or interpreted to the disadvantage of either Buyer, BBA, or Seller by any court or other governmental or judicial authority by reason of either party having or being deemed to have drafted, structured, or dictated such provision.

(F) Survival: The representations, warranties, and covenants contained in these terms or in any document, exhibit, instrument, certificate, or schedule furnished in connection with these terms shall survive termination and shall continue in full force and effect.

(G) Governing Law: Bidder/Buyer agrees that any disputes arising from auctions or purchases described herein shall be subject to the exclusive jurisdiction of Chester County, PA, and hereby waives the right to a trial by jury. The validity, construction, enforcement, and interpretation of these Terms shall be governed by the internal law of the Commonwealth of Pennsylvania. By submitting a bid, the bidder consents to legal proceedings governed by Pennsylvania law, without regard to conflicts of law provisions. All disputes, claims, and litigation shall be brought in Chester County, Pennsylvania. If any term in these Terms of Sale is held invalid under present or future laws, the validity of the remaining provisions shall not be affected.
