If we have a (proper) training day (or even a few hours) each month or two, business owners will find your work gets carried out the correct way, saving \$\$\$\$.

This will reduce your call backs and you will find each task gets completed sooner than it would if your workers are not standing there wondering "how do I do this"?

If you can't do the training yourself or have one of your team do it, send your team to a recognized training place, such as MBA or HIA, etc – The Cert 111 waterproofing course is available as well which we encourage all members to get.

Contact AIW if you need some help with organizing your training.

The AIW itself does not carry out training but we can direct you to organisations that can help.

This is not rocket science but more jobs I visit and see what's going on in the industry, the more I want to pass this message along to all our members.

The AIW Delivers on the Importance of Waterproofing

On the 29th March 2017, the AIW attended and presented at the ADEB (Architects Designers Engineers Builders) Waterproofing Breakfast Seminar in Sydney which focussed on Commercial & Residential High-Rise Water-Proofing Failures and Solutions.

Paul Evans, AIW President, gave a brief overview of the AIW and the part the institute plays in raising the standards of waterproofing in Australia. Robert McDonald, an AIW member, delivered an informative session outlining the "Australian Standards in Waterproofing".

These two presentations included discussions on:

- * Common defects in waterproofing internal & external.
- * Priming
- * Substrate Moisture Content
- * Inspection & Testing of Waterproofing
- * Drainage & Waterproofing
- * Product Knowledge
- * CA 55 1970 Design and Installation of Bituminous Fabric Roofing.
- * AS 3740 Waterproofing Wet Areas in Residential Buildings.
- * As 4858 2004 Wet Area Membranes.
- * As 4654 2012 Waterproofing Membrane.

The AIW remains dedicated to acting as a vehicle for updating, providing current information and educational resources for all industries involved with waterproofing.

How do we achieve uniform waterproofing compliance, nationally? Certainly State and Territory Regulatory Authorities play a role, however current licensing requirements are disjointed and in most States not required.

Local Authorities and building surveyors request Waterproofing Application Certificates in order to certify compliance with BCA and Australian Standards. Certifiers will require that certificates are issued by a competent person.

One where the works performed are covered by the scope of their license, or a person with formal qualifications to carry out the works. Training and qualifications are regulated under the National Qualifications Framework.

Plumbers do not have the above formal qualifications in their framework, and therefore should not be issuing waterproofing application certificates, as a competent person. Builders should ensure that tilers issuing certificates carry the current qualifications for their trade.

CPC 31411 Cert III in Construction Waterproofing contains the following core competencies:

CPCCWP 3001A Apply waterproofing process to below ground level wet areas.

CPCCWP 3002A Apply waterproofing process to internal wet areas.

CPCCWP 3003A Apply waterproofing process to external wet areas.

How Do I Get Qualified as a Competent Person?

There are a number of avenues available to secure a formal qualification as a Cert III Construction Waterproofer, dependant on your experience and current qualifications.

CPC 31411 is offered through selected Skills Tech (T.A.F.E) colleges as a two to four year apprenticeship, under a State government training contract with a suitably qualified host employer or group employment company.

This is suited to inexperienced candidates, covering the full range of competencies, including generic competencies applicable to other Cert III trades, such as: Work effectively and sustainably in the construction industry; Plan and organise work; Conduct workplace communication etc.

These are accompanied by trade specific core competencies, as mentioned above. There are 14 core competencies with 5 electives to make up the Cert III qualification. The qualification is recognised nationally, when delivered and issued by a Registered Training Organisation (RTO).

Master Builders NSW and Queensland Master Builders, as RTO's, offer a four day qualification course. This course offers all fourteen core competencies with five electives, including: frame and fit out of wet areas; install sealant devices; concreting to simple forms; levelling; and safe demolition.

This course is aimed at partially experienced practitioners, with two years waterproofing application experience supported by other industry qualifications. Accredited tilers, architects, builders, engineers, project supervisors and waterproofing applicators with partial competencies attend these courses.

Courses are offered in Sydney and throughout regional NSW; Brisbane and throughout regional Qld. MBA NSW are also supporting a Tasmanian course to be hosted in Hobart in September of 2017.

These courses are partially funded with the support of respective State Governments. This course is also planned for Victoria, to be held in the later half of the year.

The next avenue involves a Recognition of Prior Leaning (RPL). RPL's are for experienced punters with a minimum of four years practical experience in all

forms of waterproofing disciplines. Waterproofing is, normally, a specialised trade. Most practitioners apply waterproofing to either: internal wet areas and decks; or below ground and external wet areas.

Quite often gap training or practical exercises are required to evidence full competency for the complete qualification. A number of RTO's operate throughout most states offering this avenue.

Kangan Institute in Victoria, offer another avenue for qualification. This course is limited to applicants with 5 years full time waterproofing experience and is fully funded by State Government.

The qualification completion takes 6 to 12 months with 12 site visits, to your worksite, to facilitate practical raining and assessments. Any gap training required is conducted at the Broadmeadows campus.

What About Me? I Just Want to Know What Is Compliant!

Industry associations provide seminars focussing on BCA and Australian Standards compliance. These are not qualification courses, but are informative seminars.

These sessions are aimed at builders, design professionals, waterproofing practitioners and building surveyors. State regulatory authorities provide open forum seminars on BCA changes.

Aside from formal qualifications, it is important to educate other stake holders on regulatory requirements. Often builders and waterproofing applicators complain about arguing with certifiers about compliant practices.

MBA NSW are delivering one day courses, where CPD points are issued:

- 1) Australian Standards Compliance internal and external application compliance, and practical design solutions.
- 2) Further courses are under development covering Below Ground Waterproofing and Remedial Waterproofing.

HIA are delivering four by half day technical courses on waterproofing compliance. Each course runs for four hours and rewards course participants with 4 CPD points, as per State requirements.

These courses are available nationally, and cater for localised application techniques with a focus on Standards and mandatory compliance.

The courses on offer are:

- 1) Waterproofing Wet Areas AS 3740- 2010 compliance and practical design solutions.
- 2) Waterproofing External AS 4654.2-2012 compliance and efflorescence defects avoidance.
- 3) Wet Area Inspections and Defect Identification AS 3740-2010 compliance, visual defect inspections and the Shower Leak Detection Test protocols.

4) Wall and Floor Tiling Trouble Shooting – AS 3958.1-2007 compliance and defect avoidance. Functional failures and cosmetic defects.

AIW are currently developing a number of ½ day courses, focusing on Austra\[\] lian Standards Compliance, Inspections, Material Compatibility and Membrane Selection, and Best Practice Applications.

These courses will be available to all AIW members. National Committee Members will co-ordinate delivery Nationally for all regional areas.
