You can list anyone you want onto the LLC as Members who can also shield their personal assets. Each person should be listed on the Privacy trust via the Schedule of Assets .

All outstanding liabilities are subject to collections via the current S Corp and do not pass thru to the newly established Wyoming Anonymous LLC. Your Privacy Trust lists all of your personal assets and are not public and thus shield you from creditors and lawsuits.

Anonymity is so important in an Asset Protection Plan because personal anonymity is the easiest way to maintain legal distance from the liabilities associated with your business and personal assets.
