

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.velocitybusiness.net, and Velocity Business LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Velocity Business LLC include www.velocitybusiness.net and Velocity Business. The Velocity Business website is a financial services site. By using the Velocity Business website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Velocity Business may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Social Security Numbers (SSN), Employer Identification Number (EIN), Date of Birth (DOB), Company Monthly Revenue

If you purchase Velocity Business's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Velocity Business may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Velocity Business collects and uses your personal information to operate and deliver the services you have requested.

Velocity Business may also use your personally identifiable information to inform you of other products or services available from Velocity Business and its affiliates.

Sharing Information with Third Parties

Velocity Business does not sell, rent or lease its customer lists to third parties.

In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Tracking User Behavior

Velocity Business may keep track of the websites and pages our users visit within Velocity Business, in order to determine what Velocity Business services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Velocity Business. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the

Use of Cookies

The Velocity Business website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
