- Certificates issued
- Feedback or assessments submitted

d. Technical and Usage Information

- IP address

- Browser type and version
- Device information
- Pages visited and usage logs
- Cookies and tracking identifiers

3. How We Use Your Information

We may use your information for processing enrollment, delivering services, processing payments, issuing documentation, customer support, marketing (with opt-in), legal compliance, analytics, and improvements.

4. Legal Basis for Processing

We collect and process your data based on your consent, contractual necessity, legal obligations, and legitimate business interests.

5. Sharing of Data

Data may be shared with authorized staff, third-party service providers (e.g., payment processors), legal authorities, or partners (with consent).

6. Data Retention

We retain data for 5 years after the last interaction unless legally required otherwise.

7. Data Protection and Security Measures

We use SSL, firewalls, restricted access, and regular monitoring to protect data.

8. Use of Cookies

Cookies are used for session and analytics. Users can disable cookies in browser settings.

9. Your Data Privacy Rights
