What information do we collect from you?

In line with data protection laws, we are only able to process personal data where we have a valid reason to do so.

We may collect from you:

- Your name, email address and contact telephone number (so that we can communicate with you about the tuition service we provide or will potentially be providing to you and your child);
- Your child's name, school name, school year, maths set and educational background (so that we can deliver tailored and effective tuition services to your child);
- Your child's mobile telephone number and/or email address where appropriate (so that we can video call if necessary or send over homework).

We will ask you to give consent for us to process your child's information, where your child is aged 16 or under.

What do we do with the information?

We will use your personal information to fulfil tuition requests, meet our contractual obligations with you and deliver a high-quality tuition service.

We use Tutorbird as an organisational tool to store your personal information including name, email address and telephone number. We also store your child's name and their email address where provided, if consent to do so is given by you. This online tool allows us to send auto-reminders for sessions and track payments.

Sharing your information with third parties

We share your personal information and that of your child with the tutor who will be delivering the tuition service to you and your child.

We are a collaborative tuition provider and tutors may discuss individual concerns or needs in order to provide the highest quality tuition service to you and your child.

Your personal data may be transferred to countries outside the UK or European Economic Area that may not have the same laws to protect your data. You should not submit any personal data unless you accept this position.

We will not share your personal information with any other third parties without informing you first, unless we are required to do so by law.

Lawful basis for processing your data

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

- We have a contractual obligation.
- Consent

How do we keep your information safe?

We take reasonable steps to ensure that your information is kept safe and will endeavour to protect it from unauthorised access.

How long will we keep your information?

We will retain your data only for as long as necessary in accordance with applicable laws. For clients, this means we will keep your personal data whilst you are an active client of Mathematical Minds Tuition. If you do not receive any services for a period of 8 years, your data will then be deleted.

What rights do you have over your information that we hold?

- You have the right to access: you can request a copy of all the information that we hold about you, at no cost.
- You have the right to rectification: you can ask us to correct any inaccuracies in the information that we hold about you.
- You have the right to be forgotten: you can ask us to delete your personal information if there is no need for us to keep it.
- You have the right to restriction: you can ask us to restrict the personal information that we are processing, in certain circumstances.
- You have the right to object: you can tell us if you think we are using your personal information incorrectly and you would like us to stop.
