- Lawful Basis: Legitimate interests (to understand user behavior and enhance security).
- 5. Marketing Data
- Includes preferences for receiving marketing communications.
- Purpose: To deliver tailored advertisements and measure marketing

• Lawful Basis: Consent or legitimate interests (to grow our business).

### Sensitive Data:

We do not collect sensitive data such as race, health information, or political views unless explicitly required and permitted by law.

# 3. How We Collect Data

We collect data in the following ways:
