Vital Statistics:

- Name, home address, and telephone number
- Name of business or employers address and telephone number
- Occupation and title
- Social Security Number
- Social Insurance Number
- Date of birth/Place of birth
- Citizenship
- Mother's maiden name
- Father's name/Mother's name
- Father's birthplace/Mother's birthplace
- Location of will
- Location of birth certificates
- Location of deeds to property
- Location of bank account and credit card numbers
- Location of insurance policies
- Location of marriage license
- Location of funeral and cemetery arrangement certificates

Service Arrangements:

- Select casket/urn
