On a former day, to-wit, April 18, 2000, came the petitioner, the Office of Disciplinary Counsel, by Bruce A. Kayuha, Chief Disciplinary Counsel, and also came the respondent, Harry W. Moore, Jr., by Gregory J. Campbell, his attorney, and presented to the Court their joint Agreed Stipulations in which the parties agree to the following: (1) the respondent shall seek appropriate counseling with Licensed Professional Counselor Wayne Dickinson of Hillcrest Behavioral Health in Wheeling, West Virginia, upon such terms and frequency as deemed appropriate by said counselor; (2) respondent shall abide by the recommendations made by said counselor; (3) counseling reports and the records made pursuant thereto, shall be provided to the Office of Disciplinary Counsel; (4) respondent shall undergo periodic screenings for alcohol and drugs as directed by said counselor; (5) respondent's practice shall be supervised. The supervising attorney shall meet at least monthly with the respondent, be approved by the Office of Disciplinary Counsel, shall file monthly reports with the Office of Disciplinary Counsel and shall be available to respond to inquiries by the Office of Disciplinary Counsel; (6) respondent's license to practice law in the State of West Virginia shall be suspended immediately upon

a showing that the respondent has missed a court hearing or scheduled conference; (7) the foregoing conditions shall remain in place until the disciplinary proceedings against the respondent are completed; and (8) the effective date of the aforesaid conditions shall be April 20, 2000.

Upon consideration whereof, and pursuant to Rule 3.27(c) of the Rules of Lawyer Disciplinary Procedure, the Court is of opinion to and doth hereby accept the Agreed Stipulations. It is therefore ordered that: (1) the respondent shall seek appropriate counseling with Licensed Professional Counselor Wayne Dickinson of Hillcrest Behavioral Health in Wheeling, West Virginia, upon such terms and frequency as deemed appropriate by said counselor; (2) respondent shall abide by the recommendations made by said counselor; (3) counseling reports and the records made pursuant thereto, shall be provided to the Office of Disciplinary Counsel; (4) respondent shall undergo periodic screenings for alcohol and drugs as directed by said counselor; (5) respondent's practice shall be supervised.
