Refund Policy: No Refunds

After the purchase of **The Reactive Mom Reset Method** is complete, there are no refunds provided. All payments must be made according to the payment schedule.

Monthly payment plan policy:

1:1 call cancellation, reschedule and no show policy:

The Reactive Mom Reset Method requires 1 business day notice to cancel or reschedule a 1:1 coaching session. We understand that emergencies occur and will be treated on a case by case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have 1 opportunity to reschedule. If you do not show up for that rescheduled session you will forfeit the session and will not be able to rebook it.
