

## **Dr. Charles Hoffe Update: June 5, 2024**

The BC College of Physicians and Surgeons has now seen the comprehensive evidence Dr Hoffe compiled of the devastating harm caused by the Covid shots. They are determined to bury that evidence. Therefore, they applied for judicial notice of their version of "stated facts" which they claim are irrefutable, starting with the claim that Covid vaccines are "safe and effective", etc.

If the disciplinary panel grants The College judicial notice of their version of "the facts", Dr Hoffe will be prevented from submitting any evidence of vaccine injuries or of Ivermectin's effectiveness in treating Covid.

The College's disciplinary panel has stated it will give its judgement on the application for judicial notice before the end of June, 2024. This will essentially determine whether Dr Hoffe is allowed to mount a defence.

Obviously, this decision will radically affect the outcome of the trial.

Dr. Hoffe's trial is now scheduled for three weeks in October and November, 2024, at a time when the College knows that Dr Hoffe's lawyer, Lee Turner, is not available. The College seems determined to get Lee Turner off the case because of the superb evidence that he has brought forward.

Since Mr. Turner is not available for the dates the College chose, Dr Hoffe is applying for an adjournment so his his lawyer can participate in Dr. Hoffe's defence.

If the College's disciplinary panel grants judicial notice and Dr Hoffe is not allowed to defend himself, then the trial will last less than a day because it will be a simple kangaroo court conviction.

If the disciplinary panel does not grant judicial notice, the trial is likely to be very prolonged because of the massive amount of evidence of harm from the Covid shots. This mountain of evidence continues to grow every week.

The College has four lawyers working on their case against Dr. Hoffe. They are determined to bring him down by any possible means possible.

This is truly a David versus Goliath battle; Truth and Medical Ethics versus the medical industrial complex.

The College is determined to make an example of Dr. Hoffe. If they are successful, they will effectively browbeat all other doctors into submissive silence.

But, time and truth go hand-in-hand and universe is ruled by Almighty God, and He is the God of justice and truth. The truth always comes out in the end.

**Why is this case so important?**

1. Health Canada receives 90% of its income from the pharmaceutical industry. The College is an arm of public health. Hence, the College seeks to make an example of Dr. Hoffe for revealing evidence of vaccine harm as a warning to other doctors to keep silent, and to meekly tow the party line.
