Daycare/Boarding Agreement

1. I understand that I am solely responsible for any harm caused by my dog(s) while dog(s) is/are attending Pawsitively Pets and agree to take full and financial responsibility for any damage or injury caused directly by the behavior of my dog(s) toward another dog, person or person's property. _____ (**please initial each**)

2. I further understand that having my dog in a non-traditional boarding facility with dogs being able to pack together, that disagreements will occur between dogs. Pawsitively Pets will, with all due diligence, make every attempt to intervene and redirect our guests in order avert any injury. If an injury does occur, Pawsitively Pets will provide needed medical attention, either on site or by a veterinarian. _____

3. It is expressly agreed by Owner and Pawsitively Pets that if Pawsitively Pets is at fault, then the liability shall in no event exceed the less of the current chattel value of a pet of the same species or the sum of \$400 per animal. _____

4. I further understand and agree to take full responsibility for by taking precautions against contagious illness and parasite exposure by consulting my veterinarian. I further agree in admitting my dog(s), that Pawsitively Pets has relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggression or threatening behavior towards any person(s) or any other animal. _____

5. I further understand that Pawsitively Pets and their staff and volunteers will not be liable for any problems that develop provided reasonable care and precautions are followed. The owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Pawsitively Pets, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet. _____

6. Recommended Drop-off and pickup times are 6-9 am and 4-8pm. All other times must be arranged in advance. We appreciate the courtesy of letting us know in as much advance as possible. _____
7. Boarding consists of \$45.00 per day from day of drop off to Day of pickup inclusive. Daycare rates of \$35.00 _____
8. There is an additional fee of \$5 per day for intact dogs _____
9. There is a \$5.00 per day additional fee for giving medication to your pet _____
10. For Daycare discounts to apply, the minimum number of days must be met within a single week. _____
11. If you schedule for a certain number of days in a week, those days are still paid for even if you don't use them. You may switch days within that week without penalty.
12. Nutrition. Boarded pets fair better eating their regular diet. It is required that enough food is brought in at the time of the board, to last until pickup. It is also recommended that $\frac{1}{4}$ to $\frac{1}{3}$ more food is added due to the fact that while here at Pawsitively Pets, your pet will play longer and be more active than in general and will be hungrier than at home. If necessary, Pawsitively Pets will feed your pet, typically Purina Smart Blend or Iams at \$1.50 per meal _____
13. Bedding and Personal items: Pawsitively Pets is not responsible for damage to bedding or personal items brought to this facility by the owner/guardian. Pawsitively Pets will make every effort to insure bedding and personal items are kept safe and undamaged, however, in an open facility other pets may have access to these items. Pawsitively Pets will also make every attempt to return items freshly washed. _____
14. In the event of a problem or emergency with my dog(s), Pawsitively Pets will attempt to contact me, and if I am unable to be reached, they will attempt to reach my emergency contact person listed on the application. I understand Pawsitively Pets will have sole discretion in emergency matters and I give permission for Pawsitively Pets to acquire necessary emergency care without liability and that I assume full financial responsibility and agree to promptly pay for all medical

treatments received. In the event that Pawsitively Pets pays for any deposits or treatments, I will fully reimburse Pawsitively Pets. _____

15. I certify that I have read and understand the rules and regulations set forth in the preceding page and that I have read and understand this agreement. I agree to abide by the rules and regulations and accept all the terms, conditions, and statements of this agreement. _____

16. Payment is due upon pickup unless previous arrangements have been made. Returned checks will be assessed \$30.

17. Boarding fees are due at drop off. There are no refunds for early pickup
