

What's a Surrogate?

At its core, surrogacy is an act of selflessness and compassion. Surrogates are women who choose to carry and give birth to a child on behalf of someone else. They are women between the ages of 21-38 who have had at least one healthy full-term pregnancy and are willing to go through an 18-month journey that includes psychological and medical screenings, legal processes, injectable hormone medication, and an embryo transfer procedure. These phenomenal women provide the gift of life and hope to those who cannot conceive or carry a child on their own. In return for their time and effort, surrogates receive generous compensation.

Why become a surrogate?

Many of the people seeking the assistance of a surrogate are experiencing infertility, same-sex couples, and others who have life-threatening diseases that prevent them from carrying their own babies. For these couples, surrogates are one of the few opportunities for them to have a child and grow their family.

By becoming a surrogate, you are giving one of the greatest gifts one can give. You will be a part of something bigger than you, changing lives forever, including your own.





Surrogate Requirements

Just as intended parents undergo screening for criminal backgrounds and mental fitness, gestational carriers must also undergo a thorough screening process to ensure they are in good health and fit for the role. Each agency, including Giving Tree Surrogacy, has its own set of requirements that align with the guidelines set by the American Society for Reproductive Medicine (ASRM).

Women interested in becoming a Giving Tree surrogate must meet the following requirements:

- Have had at least one healthy full-term pregnancy.
- Are currently raising at least one child in the home.
- Must be between the ages of 21 and 38.
- Have a height-weight ratio with a BMI no higher than 31.
- Must be a legal permanent resident of the United States.
- Must have a valid Driver's License.
- Must reside in the United States.
- Must be a non-smoker in excellent health.
- Must not have a history of alcohol or substance abuse.
- Must be willing to undergo a criminal background check
- Must be willing to travel to fertility clinics.



Surrogate Compensation

If you're thinking about becoming a surrogate, you might be wondering how much you can earn. Our compensation packages include a base amount that varies depending on several factors, such as the state you live in and whether you're an experienced surrogate.

# Steps in surrogacy

#### **Application and pre-screening**

Your journey begins by completing our online application and prescreening consultation. It is important for us to assess that you meet our basic requirements and are ready for the journey ahead physically, mentally, and emotionally.

#### Screening Consultation

During your consultation, you will be meeting virtually with one of Giving Tree's Surrogate Consultants. This is your opportunity to have your questions answered and make sure this is the right path for you before making a decision to commit to this journey.

#### Matching with Intended Parents

Once you are committed to being a Giving Tree surrogate, our team will build an individual profile and begin identifying ideal intended parents to match with you.

#### Medical and Legal Screening

You have now matched with your ideal family and wish to move forward in the process, and you will be invited to the intended parents' IVF clinic to complete your medical screening, then sign legal contracts.

#### Monitoring and Appointments

Once your intended parents' IVF physician has approved you medically, you'll begin taking medication and attend regular monitoring appointments to ensure your body is responding positively to the medications.

#### Pregnancy

During this stage of the surrogacy journey, you will go for an appointment around 6-7 weeks for heartbeat confirmation. This is the most exciting time as you will have routine appointments with your OBGYN and develop a deeper bond with your intended parents.


