

Rise of Trash Easter Recovery Rally Terms and Conditions

These Terms and Conditions ("Terms") govern your participation in the Rise of Trash Easter Recovery Rally ("Promotion"), a limited-time offer for the \$TRASH token presale conducted by Rise of Trash, a decentralized anti-scam project focused on blockchain fraud prevention and online scam recovery. By participating, you agree to be bound by these Terms. Please read them carefully.

1. Promotion Overview

The Easter Recovery Rally is a promotional event running from **April 1, 2025, to April 30, 2025** ("Promotion Period"). Participants purchasing \$TRASH tokens during the private sale at \$0.01 per token are eligible to receive a **25% bonus in \$TRASH tokens**, subject to the conditions below.

2. Eligibility

To participate in the Promotion, you must:

- Purchase a minimum of **500 \$TRASH tokens** (\$5 equivalent at \$0.01 per token) during the Promotion Period.
- Complete **Know Your Customer (KYC)** verification as required by Rise of Trash.
- Conduct transactions exclusively on the **Base network**. Transactions on other networks will not qualify and may result in permanent loss of funds.
- Be at least 18 years old and comply with applicable laws in your jurisdiction.

3. Bonus Details

- **Bonus Structure:** For every \$TRASH token purchased, you will receive an additional **0.25 \$TRASH tokens** (e.g., buy 1,000 tokens, receive 250 bonus tokens).
- **Maximum Bonus:** Limited to **50,000 bonus \$TRASH tokens** per wallet (\$500 equivalent at \$0.01).
- **Bonus Pool:** Total bonus allocation is capped at **2,000,000 \$TRASH tokens**, distributed on a first-come, first-served basis. Once depleted, no further bonuses will be awarded.

- **Delivery:** Bonus tokens will be credited to your wallet after the private sale ends (on or before May 15, 2025).
- **Vesting Schedule:** Bonus tokens are subject to a **6-month lockup period** starting from the credit date, followed by **linear vesting over 12 months** (1/12th released monthly).

4. Restrictions

- **Non-Combinable:** The Promotion cannot be combined with other offers or discounts.
- **Non-Transferable:** Bonus tokens are non-transferable until fully vested.
- **Non-Refundable:** Purchases and bonus tokens are non-refundable, except as required by applicable law.
- **One Per Wallet:** Only one bonus allocation per verified wallet address is permitted.

- **Market Risk:** The value of \$TRASH tokens, including bonus tokens, is subject to market fluctuations and may increase or decrease. There is no guarantee of profit or return on investment.
- **Project Risk:** Rise of Trash is a community-driven project, and its success depends on collective efforts. There is no assurance of achieving stated goals, including scam recovery or platform development.
- **Regulatory Risk:** Cryptocurrency regulations vary by jurisdiction. You are responsible for ensuring compliance with local laws.
- **Technical Risk:** Blockchain transactions carry risks, including network errors or hacks. Rise of Trash is not liable for losses due to technical issues beyond its control.

6. Network Compatibility

\$TRASH tokens and the Promotion operate exclusively on the **Base network**. Using other networks (e.g., Ethereum, Binance Smart Chain) for transactions will result in **permanent loss of funds**. Verify network settings before participating. Rise of Trash is not responsible for losses due to incorrect network usage.

7. KYC and Compliance

- **KYC Verification:** Participants must complete KYC verification to receive bonus tokens. Failure to comply will result in forfeiture of the bonus.
- **Anti-Money Laundering (AML):** Rise of Trash complies with AML regulations. Suspicious activities may lead to account suspension or bonus cancellation.
- **Jurisdictional Restrictions:** The Promotion is void where prohibited by law. Residents of restricted jurisdictions (e.g., U.S.-sanctioned countries) are ineligible.
