**DEPOSIT**

(Surety of Action Deposit) in the amount of **\$500** is **required** to hold this Puppy for the Buyer until the date of Pick up.

**THERE ARE NO REFUND ON DEPOSITS.**

Failure of the Buyer to complete this purchase would subject Seller to lost opportunities to sell the Puppy to some other Buyer and retention of the Deposit is meant to compensate Seller for his possible loss. This applies if the Buyer is reserving for the upcoming litter, the deposit won't be refunded if the Buyer chooses not to purchase the Puppy or the female doesn't take **(if female doesn't get pregnant, the deposit will go to the next litter)**. This deposit signifies the intent on the part of the Buyer to follow through with the Purchase of this Puppy. If injured before it goes to its new home then, of course, the deposit will be returned to the Buyer; unless the Buyer wishes to apply the Deposit to another Puppy, **IF ONE IS AVAILABLE, OR TO ANOTHER PUPPY FROM THE NEXT AVAILABLE LITTER.**

**DELIVERY DATE:**

This Puppy will be available for the Buyer to pick up personally on :

**LATE FEE:**

If the puppy is not picked up on the date agreed on, **there will be an additional charge of \$40 PER DAY.**

**SHIPPING & HANDLING FEES:**

The Buyer is responsible for shipping & handling delivery fees. There is an addition of **\$100 FEE** for the cargo puppy crate. Once the puppy's flight is confirmed, the buyer must pay the full remaining balance of the purchase price amount.

**HEALTH GUARANTEE:**

The Seller guarantees your Puppy to be free from infectious diseases and guarantees the Puppy is in good general health and that has no known physical defects. Deworming and 1st immunizations will have been completed by the seller and the seller will provide immunization records to the buyer. Heart defects are covered by this guarantee for 1 year from the purchase date, a written examination from 2 veterinarian must state that heart defect exists and be accompanied by X-RAYS and other testing as appropriate with documentation by a veterinarian, that is dated within 1 year of buyers receipt of the puppy that shows serious untreatable heart genetic defect which is sufficiently serious in the opinion of a qualified veterinarian. The buyer will be given a replacement puppy from the seller's next available litter. Expenses of the treatment, exams and tests are the financial responsibility of the buyer. If the dog(s) develops hip dysplasia prior to 12 months of age as evidenced by the written **Orthopedic Foundation** for animal's report, supplied by Buyer to Seller, based on X-RAYS submitted to OFA, the Seller agrees to supply a replacement puppy. If a puppy is diagnosed with PARVO after leaving the breeders house, and ends up dying, **THERE WILL BE NO REFUND OR DOG REPLACEMENT**. The puppy will come with its first PARVO vaccines before rehoming.

**GENERAL:**

This written agreement contains all the terms of this Puppy Deposit and Sales Agreement. No refund will be given. **ALL DEPOSITS ARE NON-REFUNDABLE & ALL SALES ARE FINAL.** To ensure that the Buyer can immediately reserve the Puppy of their choice. Buyer and Seller agree that this Agreement is in full force exchange of completed copy of this agreement between Seller and Buyer.
