

Self Assessment (SA)

For Individuals to submit Self Assessment tax returns online, view statements and make payments including a Direct Debit payment option.

VAT EC Sales List (ECSL)

For UK VAT Registered businesses making supplies of goods to VAT Registered businesses in other EC member states.

VAT EU Refunds

Allows VAT registered businesses in the UK to reclaim VAT paid on goods and services bought and used for business purposes while visiting other EU Member States. Enrolment can take up to 7 days so it's best to enrol as soon as possible to avoid missing the 30 September deadline for making refund claims.
