# TRASH/RECYCLE/ORGANICS BINS



You've probably recently received your 2023 appraisal from BCAD. Our home values in Blanco Woods are holding up well at higher levels than in the past.


As of this writing, there are 2 homes on the market in the neighborhood, with one of them under contract after less than 2 weeks. So far in 2023, we have not seen any home sales, but as the weather warms and

we move into the most active time of the year for home sales, that will most likely change.

If you moved into Blanco Woods in 2022, be sure you have applied for your homestead exemption and any others you may qualify for before the May 1st deadline. There is no charge to apply and you can do so online at BCAD.org.

#### **HELP PREVENT OAK WILT**

In order to prevent the devastating effects of Oak Wilt, oak trees, <u>SHOULD NOT be pruned or cut</u> <u>down between FEBRUARY 1 - JUNE 30</u>. During approved pruning dates, please be sure to hire a licensed tree pruner and make sure they spray the wounds *immediately* using latex or commercial tree wound paint.
