### **REAL ESTATE UPDATE IN SAN ANTONIO AND IN BLANCO WOODS**



Blanco Woods continued to be a popular neighborhood with home buyers in 2023!

Last year there were 8 home sales, with one home bought and sold twice! Sales prices ranged from \$340,000 to \$567,500 with the average being \$415,625. Sold properties averaged approximately 96% of their final list price. The average number of days on the market was 39, although the range was from 17 to 82.


As of this writing, there are currently no properties on the market.
