### **1.**Overview

This Website is owned or operated by Capital Financial Solutions LLC (collectively, "Credit Surge University"). This privacy policy ("Privacy Policy") applies to information that you provide to Credit Surge University via this Website, and/or when you use our Services and/or purchase our Products, including as set forth below and as defined in the applicable Terms and Conditions.

This Privacy Policy is intended to provide you notice of Credit Surge University's information management practices, including the types of information gathered, how it is used and safeguarded, and the degree to which you may control the maintenance and sharing of your information. Your use of any Credit Surge University Service or Website constitutes acceptance of this Privacy Policy and any other applicable terms.

We guarantee that your Personal Information is protected by the California Consumer Privacy Act (CCPA) and California Online Privacy Protection Act (CalOPPA), as well as the Children's Online Privacy Protection Act (COPPA) and the CAN-SPAM Act of 2003, in force in the United States of America, including the General Data Protection Regulation (GDPR) approved by the European Parliament; and by all applicable international privacy and data protection treaties in effect.

By continuing to use our Services through the Website and any other applications associated therewith and clicking Accept on the bottom found at the end of this document you are expressly granting your consent to this Privacy Policy.

## **3.**Personal Information That We Collect

Credit Surge University respects your privacy and is committed to protecting the Personal Information that you provide in connection with your use of its Websites and Services.

a) Personal Information You Provide:

When you use our Website and Services, you may be asked to enter your Personal Information collected, including your name, last name, email, and payment information such as your credit card number ("Personal Information" and/or "Information").

b) Personal Information Automatically Collected by Us:

Through the use of the Website, we may use third party data collection technology ("Data Collection Companies") to collect information related to your use of the Website. Generally speaking, this includes information about your geographic location and Site behavior. The Data Collection Companies also provide us with information about what type of device or software you use, your IP address (with location information), and whether you view the Website on mobile, tablet, or desktop.

We collect this information for statistical purposes only and to improve the viewer experience.

## 4. Update or Correction of Your Personal Information

### **5.** When Do We Collect Personal Information?

We collect Personal Information from you when you sign up or enter your Personal Information on the Website and use our Services as well as fill out any of our forms. If you're just viewing the Website, you won't be required to provide your Personal Information to us.

### **6.** How Do We Use Your Personal Information?

When using the Website and Services, we may use the Personal Information we collect from you when you register on our Website, purchase any of our Products, respond to a survey or marketing communications (typically by email), browse the Website, or use certain other Website features in the following ways:

- To personalize your experience and to provide our Products and Services offerings in which you are most interested.
- To improve our Website in order to better serve you.
- To allow us to better serve you in response to your requests.
- To administer a contest, promotion, survey, or any other Website feature.
- To quickly process your transactions on and for the Website and/or Products and/or Services.
- To send periodic emails regarding the Website, Products, and/or Services.

### 7. Non-Personal Information That We Collect

As part of the registration process for providing our Products and/or Services, you may be asked to provide information that does not personally identify you ("Non-Personal Information"). For example, you may be asked to provide information concerning your personal preferences, purchasing habits, and the like. This information is generally optional but may be included in your User Account profile. Credit Surge University requests this information to understand you better

In many cases, Credit Surge University will automatically collect certain Non-Personal Information about your use of its sites and Services. Likewise, if you provide information to other companies who share information about their customers or users, we may collect additional information about you. ## **9.** Information About Other People

This Privacy Policy does not apply to any information you may disclose publicly in such Services. In some instances, you may choose to create a "Public Profile" that will be available to others on the Internet. Credit Surge University bears no responsibility for any action or policies of any third parties who collect any information that Users may disclose in User forums or other public areas of this Website. ## 12.Use, Disclosure, and Sharing of Information

We do not use and/or share and/or sell and/or trade and/or exchange and/or publish any of your Personal Information with third parties for any purposes without your express consent.

### a) Non-Personal Information

From time to time, Credit Surge University may use and share with third parties aggregate, Non-Personal Information to show general demographic and preference information among Users of our Website. When you visit or download information from this Website, our web servers may automatically collect Website usage information. Website usage information is non-personally identifying information that describes how our visitors use the Website. It can include the number and frequency of visitors to each web page and the length of their stays, browser type, refer-

rer data that identifies the web page visited prior and subsequent to visiting the Website, and IP addresses (see below for more information on IP addresses). Credit Surge University may use IP addresses for a number of purposes, such as system administration, to generally determine your computer's server location, to report aggregate information to our business partners or to audit use of the Website. We also may determine your screen resolution and the technology available in order to serve you the most appropriate version of a web page, e-mail or similar service.

#### b) Personal Information

Credit Surge University may also use IP addresses it collects in cooperation with Internet service providers, to identify Users if we deem it necessary to comply with law, to enforce compliance with this Privacy Policy or our Terms and Conditions, or to protect our Website, Users, or others.

## 13. Data Protection and Security

While Credit Surge University takes reasonable and appropriate precautions to protect your Personal Information from unauthorized disclosure and to prevent possible security breaches in our Website, Services, and Users databases, no website, Internet transmission, computer system, or wireless connection is completely secure. Consequently, Credit Surge University cannot guaran-

tee that unauthorized access, hacking, data loss, or other breaches will never occur. Your use of Credit Surge University Websites and Services is at your own risk. Credit Surge University urges you to take steps to keep your information safe by memorizing your password or keeping it in a safe place (separate from your account information), logging out of your User Account, and closing your Web browser.

## **16.**Emails and Text Messages (SMS)

Credit Surge University will send emails or text messages ("SMS") to you, from time to time, to let them know about Products offers and important improvements and updates to our Website and its Services. You will be able to opt out of these emails and/or SMS at any time by clicking the unsubscribe option. However, other emails or SMS will be sent to you as system notifications necessary for the operation of the Website and its Services for which you may not deactivate this option.

## **17.**Consent to Processing in the United States of America

By providing any Personal Information to Credit Surge University, all Users, including, without limitation, Users in the member countries of the European Union, fully understand and unambiguously consent to this Privacy Policy and to the collection, storage, sharing and processing of such Personal Information in the United States of America in accordance with this document.

## 18. Cookies and Related Technology

This Website's pages or email messages may contain cookies, web beacons (also known as clear gifs), or similar technologies as they become available. Cookies are information files that this Website may place on your computer to provide extended functionality. Credit Surge University may use cookies for a number of purposes, such as tracking usage patterns on the Website, measuring the effectiveness of advertising, limiting multiple responses and registrations, facilitating your ability to navigate the Website and as part of a verification or screening process. Most browsers are initially set up to accept cookies. Most browsers will allow you to erase cookies from your computer hard drive, block acceptance of cookies, or receive a warning before a cookie is stored. ## **20.**California Consumer Privacy Act (CCPA)

  - vi) Inferences drawn from any of the Personal Information listed above to create a profile or summary about, for example, an individual's preferences and characteristics.

We collect this Personal Information from you and from other categories of sources: information received as part of routine card verification (fraud) checks; social networks; publicly available databases; and joint marketing partners, when they share the information with us.

We share this Personal Information with our affiliates, successors-in-interest, clients, service providers, data processors, business partners, auditors, advisors and public or government authorities.

- b) We disclosed the following Personal Information to third parties (such as our service providers, data processors, business partners, auditors, advisors and public or government authorities) for our operational business purposes:
  - i) Identifiers, such as name, last name, contact information, Credit Surge University identifiers and any other government-issued ID numbers;
  - ii) Personal information, as defined in the California customer records law, such as name, last name, contact information and financial information;
  - iii) Commercial information, such as transaction information, purchase history and financial details;

- iv) Internet or network activity information, such as browsing history, Credit Surge University behavior, and interactions with our and other websites, applications and systems;

If you are a California resident, you may request that we:

- i) Disclose to you the following information covering the 12 months preceding your request:
- The categories of Personal Information we collected about you and the categories of sources from which we collected such Personal Information;
- The specific pieces of Personal Information we collected about you;
- The business or commercial purpose for collecting Personal Information about you;
- The categories of Personal Information about you that we otherwise shared or disclosed, and the categories of third parties with whom we shared or to whom we disclosed such Personal Information.
- ii) Delete Personal Information we collected from you.

We will respond to your request consistent with applicable law. Nonetheless, you have the right to be free from unlawful discrimination for exercising your rights under the CCPA.

iii) How to Make Requests.

## **21.**California Credit Surge University Privacy Protection Act (CalOPPA)

## **23.**General Data Protection Regulation (GDPR)

### b) Right to Data Access and Portability

You may issue queries or ask questions about your Personal Information by email at any time, and we will provide you with such information in a structured, commonly used, machine-read-

able format, or (where technically feasible) to have it ported directly to another data controller, provided this does not adversely affect the rights and freedoms of others.

### c) Right to Data Rectification

You have the right to ask us to update and/or rectify and/or complete your inaccurate or incomplete Personal Information.
