Factory-Built Wood Double-Hung Window Limited Warranty

Glass

Magbee Contractors Supply guarantees and warrants, subject to the conditions and restrictions stated below, that each Magbee Insulated Glass unit shall be free from any material obstruction to vision due to film formation or dust collection on the interior glass surfaces resulting exclusively from the failure of the hermetic seal, other than through glass breakage for twenty (20) years to the home into which they are installed commencing on the original date of purchase and thereafter. In years eleven through twenty, we will provide replacement glass at 50% of the then current list price. The limited warranty is made and extends only to the original purchaser of such windows from Magbee and owner occupied single-family residence at the time of initial installation. It may not be assigned or transferred and shall not extend to subsequent owners. In the event glass is replaced according to the terms of this limited warranty, the replacement glass is warranted only for the remainder of warranty period applicable to the original glass. If failure occurs Magbee will ship replacement glass at no charge to the address where the window was originally purchased.

The following applied to the warranty stated above:

The provisions set forth herein constitute the maximum liability of Magbee with regard to the product warranted. Except as provided above, in no event shall Magbee pay for the cost of labor, installation, freight or finishing of either the original insulated glass of the replacement unit, or any other incidental cost related thereto. All other claims due to special, indirect, consequential, or indirect damage are also excluded from this warranty. Magbee specifically disclaims any implied warranties of merchantability and fitness for a particular purpose and makes no other warranty or guarantee, either express of implied, except as expressly contained herein with respect to its insulated glass units. In the event state law precludes exclusion or limitation of implied warranties, the duration of any such implied warranty and the time and manner of presenting any claim thereon shall be the same as the provided in the express warranty stated herein.

This warranty shall not apply to units sold or installed outside the United States, or units damaged in handling or installation. This warranty shall also be void if the unit is subjected to stresses resulting from: Localized application of heat causing excessive temperature differentials over the glass surfaces, or excessive vibration, or movement of building or foundations.

Claims under this warranty must be made as soon as practicable after discovery of the defect and in all events pior to the beginnings of any repair work to Magbee Contractors Supply. Written claims must detail the nature of the problem and the name, address, and telephone number of the person making the warranty claim. No warranty claim shall be considered properly made unless it contains the forgoing in writing and is received by unit alleged as being defective under this warranty, field inspected by a qualified factory representative and, if needed, returned to the factory. No distributor, dealer, or representative of Magbee has the authority to change or modify this warranty, either orally or in Writing, in any respect.

Components Other than Glass

Non-glass portions of Magbee factory built wood windows (including locks, lifts, balance systems, weatherstripping and sash and frame members) are guaranteed to be free of manufacturing defects for one (1) year from the original date of purchase. The one (1) year time frame only includes the original purchase from Magbee Contractors Supply and is not calculated from the date of purchase of the structure such windows were installed, nor is it calculated from the date of installation, unless windows were installed by Magbee Installation Services. If windows were installed by Magbee, the warranty is one (1) year from the date of installation. This warranty is in addition to any warranty from the respective manufacturers of component pieces used to make factory built wood windows.

A Magbee representative must inspect any and all products a customer may believe to have manufacturing defects.

AN INSPECTION FEE WILL BE APPLIED TO ALL ON-SITE PRODUCT INSPECTIONS FOR ANY CUSTOMER FOR ALL CLAIMS MADE BEYOND ONE YEAR FROM THE ORIGINAL DATE OF PURCHASE REGARDLESS OF APPLICABLE PRODUCT WARRANTIES.

Magbee will investigate as to determine if individual components fall under their respective warranties (if any) to Magbee. In such event, repairs may be reimbursed partially or in whole to the customer from Magbee through the respective manufacturers.

What is Not Covered by this Limited Warranty

Product failure or damage due to improper installation or modifications including:

- Units were not painted immediately after installation with a minimum of one coat of latex paint. Vinyl exterior parts that are to be painted in dark colors require a vinyl approved paint.
- Wood exterior parts were painted in any color darker than SW 7005 (white).
- Failures due to product modifications or glass shading devices (e.g. glass tinting, security systems, improper painting or staining, insulated coverings, etc)
- Units improperly assembled or improperly mulled by others.
- Failure to the application of non-Magbee supplied products.

Damaged caused by the following:

- Damage due to improper installation, maintenance, or use.
- Damage to the product caused by water infiltration other than as a result of a defect in manufacturing, materials, or work manship
- Damage due to condensation.
- Damage to glass caused by others (e.g. brick wash, sanding, or improper washing).
- Damage caused by failing to properly seal the exposed wood portions of a product causing rot or other deterioration.
- Damage caused by chemicals or airborn pollutants, such as salt or acid rain.
- Damage that occurs during delivery by others.
- Damage caused by accidents or acts of God.
- Damage as a result of normal wear and tear.

General Conditions

The limited warranty set forth in the document is the only express warranty (wheather written or oral) applicable to Magbee Contractors Supply factory wood windows. No one is authorized to modify or expand this limited warranty. All warranty claims must be made during the applicable warranty period.
