Privacy Policy and Terms & Conditions

Refund Policy

After the purchase of Fit & Fueled: A Blueprint to Weight Loss & Vitality is complete, no refunds will be provided. Due to the digital nature of the product and immediate access to proprietary materials, all sales are final. All payments must be made according to the agreed-upon payment schedule.

Lifetime or Ongoing Access Policy

You will retain **lifetime access** to the **Fit & Fueled Content Hub**, which includes all lessons, handouts, and program materials, even after your designated program timeframe has ended. However, **access to the Fit & Fueled Facebook group and coaching calls will end 4 months from your date of enrollment**, allowing additional flexibility beyond the 12-week core curriculum. Options for continued support beyond the program will be offered and discussed during the wrap-up call.

NOTE: Any **unused 1:1 coaching calls must be used within 4 months of your enrollment date**. After this 4-month period, any remaining calls will expire and will no longer be available for use.

Monthly Payment Plan Policy

If you are enrolled in a monthly payment plan, you are required to fulfill all monthly payments, regardless of your level of participation in *Fit & Fueled*. Non-payment may result in revoked access to the Content Hub and coaching services.

Declined Payment Policy

You are required to maintain current payments. If a payment fails, you will have 5 business days to bring your account into good standing. Failure to do so may result in denied access to both your Content Hub and coaching.

1:1 Call Cancellation, Reschedule & No-Show Policy

Fit & Fueled requires 1 business day notice to cancel or reschedule a 1:1 coaching session. We understand that emergencies occur and will be treated on a case-by-case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have 1 opportunity to reschedule. Failure to attend the rescheduled session will result in forfeiting that coaching call. Please note: Group coaching calls are not eligible for make-ups or rescheduling. If you miss a group session, you will have access to the replay (if available), but no individual accommodations will be made for missed attendance.

Hours Of Operation

Melanie's Wellness Collective offers the following hours of operation: **Monday through Thursday, 9:00 AM to 5:00 PM CT**. All client communications, including messages in the Fit & Fueled Facebook group, will receive a response within **one business day** during these hours.
