Modern Slavery Policy 2025

Introduction:

- **Suppliers**: Suppliers and subcontractors are required to adhere to this policy and demonstrate compliance throughout their operations.

Continuous Improvement:

Serv Contracts Limited are committed to continuously improving its efforts to combat modern slavery.

We will:

- Review and update this policy regularly.
- Monitor and assess the effectiveness of our processes for identifying and eliminating modern slavery risks.

Consequences of Non-Compliance
