BYLAWS

ARTICLE I: Name

Henrietta Creek Land Owners Association

ARTICLE II: Purpose

To be organized as a group for the betterment of Henrietta Creek Estates and for the protection of the land owners.

ARTICLE III: Area (Borders)

Henrietta Creek Land Owners Association boundaries are in the Hamilton Perry Survey Abstract numbers including A-1022, A-2016, A-906, A-1569, known as Henrietta Creek Estates.

ARTICLE IV: Membership

Any property owner that is current with their dues in the area described above is eligible to be a member of the Henrietta Creek Land Owners Association.

ARTICLE V: Voting:

- A. Two (2) votes per land owner regardless of type of ownership and is a current member in good standing of the Association has the right to vote.
- B. Membership in attendance at any meeting shall constitute a quorum.

ARTICLE VI: Dues

Yearly dues of \$25.00. One membership per land owner regardless of type of ownership.

ARTICLE VII: Meetings

- A. Notice 7 days in advance of meeting by mail.
- B. Place to be named in formal notice.
- C. Special may be called by any member of the executive board at any time.
- D. Regular Every four (4) months
- E. Order of business -
 - 1. Call meeting to order
 - 2. Communications and bills
 - 3. Report of Treasurer
 - 4. Reading of minutes of Previous meeting
 - 5. Report from Committees
 - 6. Unfinished business
 - 7. New business

- 8. Dismissal by motion
- F. Speakers on any subject shall be limited to five (5) minutes.
- G. Question of parliamentary nature shall be decided by Roberts Rule of Order.

ARTICLE V11: Executive Officers

- A. Executive Officers shall be 1 Chairman, 2 Vice Chairman, a Recording Secretary, and a Treasurer.
- B. Nominations of officers
 - 1. Nomination of officers will be made from the floor.
 - 2. Consent must be obtained from the nominee.
 - 3. Voted on by membership.
 - 4. Term of office is 1 year, but not limited to 1 term.
- C. Eligibility and Duties
 - 1. Officers must be a resident of Henrietta Creek Estates and a current member of the Land Owners Association in good standing.
 - 2. Executive Officers will be empowered to pay all bills, rental fees for meetings, office supplies and materials for mailing concerning the Henrietta Creek Land Owners Association.
- D. Meetings: Officers will meet 5 to 7 days before any meeting of the membership.

Article IX: Changes of By-Laws

These By-Laws may be amended, rescinded, or changed by presenting a motion on the floor and submitted in writing at any membership meeting. At the following membership meeting the change will be voted on. This must pass by a 2/3 majority vote.
