Refund Policy

In order to be eligible for a refund for The Total Digestive System Reset, you must provide a medical reason why you're unable to complete the program within the first 2 weeks of the program. You can email your request and explanation to admin@holisticharmony.ca. If you qualify for a refund and paid in full, a full refund will be provided within 7 business days. If you qualify for a refund and paid on a payment plan, your initial payment will be refunded within 7 business days and all future payments will be canceled.

Lifetime or ongoing access policy:

You have ongoing access to The Total Digestive System Reset content hub. That means that after the 16 week program timeframe is complete, you will retain access to the content hub. The program timeline is built with additional weeks to account for various start times or delays. You will continue to have access to the program Facebook group and coaching for continued support until you complete the program. Once you've completed the protocols, you can leave the Facebook program group if you'd like. You're also welcome to remain and help support any future cleansers on their journey as well.

After your program timeframe is complete, any unused 1:1 coaching calls will no longer be available for use after the program timeframe is complete.

There will be options for paid additional 1:1 coaching sessions if needed.

Monthly payment plan policy:

If you are on a monthly payment plan, you are required to complete all of your monthly payments regardless of your activity in The Total Digestive System Reset. Failure to complete your monthly payments may result in denied access to your content hub and coaching.

Declined payment policy:

1:1 call cancellation, reschedule and no show policy:
