Veterans Day

What You Know and Some You Didn't Know About Veterans Day

Major hostilities of World War I were formally ended at the 11th hour of the 11th day of the 11th month of 1918, when the <u>Armistice with Germany</u> went into effect. The United States originally observed this event as Armistice Day, a day set aside as a U.S. legal holiday to honor World War I veterans and the end of World War I. A Congressional Act (52 Stat. 351; 5 U.S. Code, Sec. 87a) approved May 13, 1938, made the 11th of November in each year a legal holiday: "a day to be dedicated to the cause of world peace and to be thereafter celebrated and known as 'Armistice Day'."

On November 11, 1919, U.S. President <u>Woodrow Wilson</u> issued a message to his countrymen on the first Armistice Day, in which he expressed what he felt the day meant to Americans: ADDRESS TO FELLOW-COUNTRYMEN The White House, November 11, 1919.

A year ago, today our enemies laid down their arms in accordance with an armistice which rendered them impotent to renew hostilities and gave to the world an assured opportunity to reconstruct its shattered order and to work out in peace anew and luster set of international relations. The soldiers and people of the European Allies had fought and endured for more than four years to uphold the barrier of civilization against the aggressions of armed force. We ourselves had been in the conflict something more than a year and a half.

With splendid forgetfulness of mere personal concerns, we remodeled our industries, concentrated our financial resources, increased our agricultural output, and assembled a great army, so that at the last our power was a decisive factor in the victory. We were able to bring the vast resources, material and moral, of a great and free people to the assistance of our associates in Europe who had suffered and sacrificed without limit in the cause for which we fought.

Out of this victory there arose new possibilities of political freedom and economic concert. The war showed us the strength of great nations acting together for high purposes, and the victory of arms foretells the enduring conquests which can be made in peace when nations act justly and in furtherance of the common interests of men.

To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service, and with gratitude for the victory, both because of the thing from which it



has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of nations.

WOODROW WILSON

The United States Congress adopted a resolution on June 4, 1926, requesting that President <u>Calvin Coolidge</u> issue annual proclamations calling for the observance of November 11 with appropriate ceremonies.

In 1945, <u>World War II</u> veteran Raymond Weeks from <u>Birmingham</u>, <u>Alabama</u>, wanted to expand Armistice Day to celebrate all veterans, not just those who died in <u>World War I</u>. Weeks led a delegation to General Dwight Eisenhower, who supported the idea of National Veterans Day. Weeks led the first national celebration in 1947 in Alabama and annually until his death in 1985.

In early 1954, U.S. Representative <u>Ed Rees</u> from <u>Emporia, Kansas</u>, presented a bill establishing the holiday through Congress. President <u>Dwight D. Eisenhower</u>, also from Kansas, signed the bill into law on May 26, 1954. It had been eight and a half years since Raymond Weeks held his first Armistice Day celebration for all veterans.

On June 1, 1954, after having been through both World War II and the Korean War, the 83rd U.S. Congress -- at the urging of the Veterans Service Organizations -- amended the Act of 1938 by striking out the word "Armistice" and inserting the word "Veterans" and by combining the observance with Victory in Europe Day (VE Day: 08May1945) and Victory in Japan Day (VJ Day: 14August 1945). Thus, with the approval of this legislation, Nov. 11 became a day to honor American veterans of all wars.

The National Veterans Award was also created in 1954. Congressman Rees of Kansas received the first National Veterans Award in Birmingham, Alabama, for his support offering legislation to make Veterans Day a federal holiday.

In 1968, the Uniform Monday Holiday Bill ensured three-day weekends for federal employees by celebrating four national holidays on Mondays: Washington's Birthday, Memorial Day, Veterans Day, and Columbus Day. Under this bill, Veterans Day was moved to the fourth Monday of October. Many states did not agree with this decision and continued to celebrate the holiday on its original date. The first Veterans Day under the new law was observed with much confusion on the fourth Monday of October (Oct 25, 1971; Oct 23, 1972; Oct 22, 1973; Oct 28, 1974; Oct 27, 1975; Oct 25, 1976, and Oct 24, 1977).

On September 20, 1975, President Gerald R. Ford signed a law which returned the annual observance of Veterans Day to its original date of Nov. 11, beginning in 1978. Since then, the Veterans Day holiday has been observed on Nov. 11.

While the legal holiday remains on November 11, if that date happens to be on a Saturday or Sunday, then organizations that formally observe the holiday will normally be closed on the adjacent Friday or Monday, respectively.

Because it is a federal holiday, some American workers and many students have Veterans Day off from work or school. When Veterans Day falls on a Saturday then either Saturday or the preceding Friday may be designated as the holiday, whereas if it falls on a Sunday it is typically observed on the following Monday. When it falls on weekend many private companies offer it as a floating holiday where employee can choose some other day. A Society for Human Resource Management poll in 2010 found that 21 percent of employers planned to observe the holiday in 2011.

Non-essential federal government offices are closed. No mail is delivered. All federal workers are paid for the holiday; those who are required to work on the holiday sometimes receive holiday pay for that day in addition to their wages.

Since Veterans Day and the birthday of the United States Marine Corps (November 10, 1775) are only one day apart, the Marines sometimes observe both occasions as a 96-hour liberty period.

Election Day is a regular working day, while Veterans Day, which typically falls the following week, is a federal holiday. The National Commission on Federal Election Reform called for the holidays to be merged, so citizens can have a day off to vote. They state this as a way to honor voting by exercising democratic rights.

In 1982, President Ronald Reagan honored Raymond Weeks, as the driving force for the national holiday, at the White House with the Presidential Citizenship Medal. Elizabeth Dole, who prepared the briefing for President Reagan, named Raymond Weeks the "Father of Veterans Day."

Thus, Veterans Day has evolved into an official <u>United States public holiday</u>, observed annually on November 11, that honors all <u>military veterans</u>; that is, all persons who served in the <u>United States Armed Forces</u>, not <u>just veterans of World War I</u>. It coincides with other holidays, including <u>Armistice Day</u>, <u>VE Day</u>, <u>VJ Day</u> and <u>Remembrance Day</u>, celebrated in other countries that mark the anniversaries of the end of <u>World Wars I & II</u>.

Veterans Day is not to be confused with <u>Memorial Day</u>, a U.S. public holiday in May; Veterans Day celebrates the service of all U.S. military veterans, while Memorial Day honors those who *died* while in military service. It is also not to be confused with <u>Armed Forces Day</u>, a U.S. remembrance that also occurs in May, which specifically honors those *currently serving* in the U.S. military.

While the holiday is commonly printed as *Veteran's Day* or *Veterans' Day* in calendars and advertisements (spellings that are grammatically acceptable), the United States Department of Veterans Affairs website states that the attributive (no apostrophe) rather than the possessive case is the official spelling "because it is not a day that 'belongs' to veterans, it is a day for honoring all veterans."

Judge Advocate message

We should always remember that words and actions count. A slight or a misquote can and will hurt feelings, and worse, it can directly affect the safety and wellbeing of other Veterans.

Not that many years ago a Veteran was denied his veteran benefits because of his religious belief and ethnic background. It all started during World War II when a Veteran was harassed when other soldiers found out that he was Jewish. Over many months, he was assaulted and insulted to the point where he developed an ulcer that resulted in his discharge from military service. His condition continued to deteriorate, and this Veteran attempted to get help from the Veterans Administration, to no avail. The VA did not recognize verbal abuse as a condition that would merit compensation.

After years of this invisible injury, the Veteran received the benefits due to him. His injuries were both physical and physiological and remain with him to this day. Even those Veterans who displayed extreme acts of courage were denied the honors that they so richly deserved - all due to prejudice or bias. It took over 50 years for a Korean War Veteran, who was also a POW, to receive the Medal of Honor that he earned in the battlefield and in the prisoner of war camps. Why you might ask, because he was Jewish. The same sergeant who ordered this veteran to numerous dangerous missions, refused to endorse his citation. This veteran died before his Medal was presented to his family in 2005. The VA Medical Center in Long Beach is now named The Tibor Rubin Medical Center after this veteran of Jewish heritage.

Words do mean something, and actions speak louder than words. A simple word of encouragement or recognition can mean a lot to anyone, especially a Veteran who may be on his" last leg." Suicide has become the number one killer of active duty military personnel. As of July 10th, the first quarter of 2018, eighty active duty soldiers, sailors, airmen and/or Marines have died as the result of suicide. Another twenty-three reserve and National Guardsmen have died as the result of suicide. More deaths than in combat activity in Iraq and Afghanistan over the past five years.

From January 1, 2014 through September 1, 2018, we have lost 37,488 of our comrades (both active and veteran) to this terrible condition. More than all the combat deaths in The Korean War and The War on Terrorism combined. How do we as Veterans halt this onslaught – being kind to each other will go a long way.

Looking out for tell-tale signs of depression in a friend or their lack of wanting to live can be giveaways. It is hard to recognize these signs, but by just treating each other with concern and friendship, we can help most people to look at things in a better way.



The Veterans Suicide Crisis Line at 1 800-273-5255 or the Tragedy Assistance Program at 1-800-959-8277 can mean the difference between life and death for a veteran who is in need.

Good evening my friends, my fellow Americans and my comrades and buddies. First, I want to thank you for who you are, the very best of America. The mere fact that you are here at the League meeting, shows your love for our country and for me and countless others. Let me tell you a little about me. I died on September 6, 1965 outside Da Nang, South Viet Nam. I was in the company of the finest men ever, United States



Marines and our Navy Corpsmen. They tried to save me, and I looked out and saw my friends, and others standing back with tears in their eyes. I had never seen them that way before. They were so sad that I had been killed and they had survived. I gave my life for my country and as Nathan Hale once said, "I regret that I have but one life to give to my country."

I was born in the heartland of America, Chicago, Illinois. My parents were Edward and Emily and they loved our country too. They sent me to Catholic schools and I grew up with many friends. In my elementary school, 5 of us went to serve our country and all five laid their lives down for our nation. 5 out of such a small school is hard to believe, but that's how I grew up. In a community that put country before self. I know each of you have a similar story, but I know that my life was given to you. You are my legacy and you will validate whether my life was in vain or for a more noble cause Peace.

I joined the Marines after High School and went directly to Marine Corps Recruit Detail, (MCRD) at San Diego. I stepped off the bus and two Drill Instructors yelled at me to get on the yellow lines. I was amazed at how quickly I learned to obey these men who controlled my life for 3 months. In Boot Camp I met Stan and he and I went to Infantry Training Regiment (ITR) together at San Onofre, Camp Pendleton. We learned to be Marines and stood by one another, another trait of being a United States Marine. We stand proud together and shoulder to shoulder. I climbed Old Smokey many times, I ran up and down the road to San Mateo and back so many times, I forgot the number. I grew strong in character and body and after ITR, I went home to visit my family; my mom, my dad and my brother and sisters. They were proud of me and I had to admit that I was very sure of myself and probably a little bit cocky, like every Marine.

I was assigned to Lima Company, 3rd Battalion, 1st Marines at Camp San Mateo in the north end of Camp Pendleton. I was billeted in a cement building with double bunks on each side of the squad bay. A common shower with 10 or more stalls, and a common wash area. I was in heaven. I had an MOS of 0351, machine gunner, the M-60. I made more friends in that time than I had ever had in my entire life in Chi Town. Stan was still with me in Machine Guns and I had another close friend, Ed. I trained hard and grew into a confident man and an excellent Marine. The old guys who had trained us left the Company in mid- 1964 and I became the trainer to more Marines who came after me.

In March 1965, I went to San Diego and boarded the USNS Brickenridge, and sailed for Okinawa via Hawaii and Japan. I arrived in Okinawa and went to Camp Hansen, which is on the east side of the island and about mid-way up the coast. I trained for a few weeks at the Northern Training Area (NTA) and sharpened my combat skills. Finally, in June 1965. I was told that our unit, 1st Battalion, 9th Marines (1/9), was headed for a place I had never heard of, Viet Nam. Our unit sailed on a three-ship convoy to Red Beach just south of where the Da Nang air base was located. We were tense in the landing craft that delivered us to the beach. We were amazed that we were welcomed my children selling us coca cola and pineapples on a stick. I recall, I felt disappointed as I wanted it to be like John Wayne on the Sands of Iwo Jima. My first lessons learned in Viet Nam, nothing is really what it looks like on the surface. We relived Marines from our brother unit 3rd Battalion, 9th Marines.

I really didn't know what to expect, but I did my duty each night guarding the air base. One night the Viet Cong penetrated our defense perimeter and killed two US Airmen and destroyed several aircraft on the air base run way. My first real taste of war. I mourned the loss of the Airmen and said a silent prayer for them.

They are both on Echo 2 East, just above me. There was a lot of action between Da Nang and another place called Marble Mountain. We were near there on March 6, 1965 and the patrol was hit hard. I ran up with my machine gun crew and began to fire. I felt a sharp pain, followed by a numb feeling. Things got blurry and I saw myself outside my body. I saw my friends trying to help me, then the Corpsman. I was placed on a Medevac helicopter and then I went silent and my soul left my body. I am only 20 years old.

Do not feel sorry for me, I am with God and I guard the streets of heaven. I prepare a place for those, who like me, give more to their country than they take. I am and was a United States Marine. Remember me and honor me with your respect and you must take up the torch and defend all that I gave my life for. You are my legacy, I am Echo 2 East-75.

My name is Lance Corporal Michael Terrance Badsing, 1st Battalion 9th Marines, The Walking Dead.

When you are In Washington DC, Visit me and all those like me at the Viet Nam Veterans Memorial. I am also present at the moving wall and you can visit me there also. But most important Remember Me and my friends who gave so much for the freedoms we love and honor today.



SPECIAL ARTICLE by Associate Member Shoubin "Jia" Yu A licensed Acupuncturist

Shoubin demonstrated the healing power of acupuncture during a prior meeting, when he and his associates performed their pain-relieving techniques to members. During this same meeting, He spoke about getting acupuncture accepted as a VA approved technique. Below is an article presented by our MCL associate member Shoubin "Jia" Yu, a licensed acupuncturist.

On September 27, 2018, MCL associate member Acupuncturist Shoubin "Jia" Yu traveled to Washington D.C. with the American Alliance of Acupuncture (AAOA). This trip was sponsored by Dr. Michelle Lau, the Chairman of the AAOA, and included the participation of more than 40 Asian medicine doctors from all over the acupuncture circles in the United States. The group met at the Rayburn House in Capitol Hall to actively participated in the joint action of the American Acupuncture and Moxibustion Alliance and lobbied to members of the Senate for acupuncture legislation.

Concurrently, they celebrated the House passage of bill H.R. 6110, Dr. Todd Graham Pain Management, Treatment and Recovery Act of 2018 which was introduced by Reps. Judy Chu (CA-27) and Jackie Walorski (IN-02), which directs the Centers for Medicare and Medicaid Services to study barriers to accessing nondrug alternatives to opioids, including acupuncture. The bills contain within it the HR6 Act that has been incorporated into include acupuncture treatments. At the same time, they also lobbied the bill H.R. 2838 Acupuncture for Our Heroes Act and H.R. 2839 Acupuncture for Heroes and Seniors Act of 2017 which promotes Congresswoman Judy Chu's proposals that acupuncture treatment become fully integrated into federal health insurance system. This joint action has been extremely resounding and successful. Among the modalities of alternative solutions to non-opioid drugs, acupuncture is a preferred method of treatment.

If the bill is passed again in the Senate and later signed by the President, this will be the official approval of the acupuncture therapy by the US federal government at the level of federal medical insurance (i.e.-Medicare). This will lay a good foundation for Chinese medicine acupuncture to enter mainstream medicine, helping integrative efforts for Hospital care, VA medical facilities and develop further complementary care in the future. The proposal has had support of several members of the National Assembly. The President of the American Chinese Medicine Acupuncture Alliance, Dr. Michelle Lau, proposed to produce a thank-you medal for the multi-discussion. One of the initiators of the bill, Rep. Judy Chu, invited some representatives to her desk to witness the positive health effects of Chinese medicine and acupuncture. She also approached other congress representatives, gave a speech and took a group photo with attendees.

Rep. Jackie Walorski, another sponsor of the bill, had arranged for her office director to receive everyone in the office because the parliamentary agenda is not in the office. After accepting the Acupuncture league's



medal that night, she immediately posted to social media, Facebook, a hand-held medal and personally expressed her gratitude to the American Chinese Medicine Acupuncture Alliance for its support of the federal bill.

Over the two days in D.C., doctors from various states had also visited the offices of the Senate and House of Representatives in their state. The event was also strongly supported by many doctors and non-doctoral volunteers. They sacrificed a lot of time and personal energy. The whole process of participating and donating at their own expense has done a lot of work in contributing to the Congressional lobbying activities. We express our deepest gratitude and heartfelt thanks!
