At **VanderSpa**, we take pride in the quality of our work, the vehicles we prepare, and the parts we stand behind. These Terms & Conditions are here to set clear expectations and help ensure a smooth experience for everyone.

If you ever have questions about an order, service, or policy, the VanderSpa team is always happy to help.

1. Pricing

Our prices may change from time to time due to supplier costs, availability, or product updates. We do our best to keep pricing accurate, but occasional errors can occur. If something doesn't look right, a may contact you before the order is finalized. You are also welcome to contact us at info@vanderspa.com

2. Orders, Processing & Shipping

Order Processing

Most orders ship within **1–2 business days**, excluding weekends and holidays. Some items may take longer due to availability, custom configuration, or special handling.

Shipping Methods

We ship using **FedEx, UPS, USPS, or freight carriers**, depending on item size and destination. Delivery timelines are estimates and not guaranteed.

Certain larger or heavier products require **truck freight**. Any additional shipping costs will be disclosed prior to shipment.

Shipping Schedule

VanderSpa ships **Monday through Friday**. Orders do not ship on weekends or holidays.

3. Free Shipping Offers

From time to time, VanderSpa offers free shipping promotions. When available:

- Applies to the **contiguous United States**
- Excludes Alaska, Hawaii, Puerto Rico, and international orders
- Does not apply to oversized or freight items
- Ships via standard ground service

Eligibility

Exchanges (No Restocking Fee)

VanderSpa offers **exchanges with no restocking fee** when:

- The item is unused and resalable
- The exchange is for the same or greater value
- Any price difference is paid at the time of exchange

Return shipping costs apply unless the item was defective or shipped incorrectly.

Refunds

Approved refunds through VanderSpa are subject to:

- **10% restocking fee**
- Original shipping charges are not refundable

Free Shipping

Steeda offers free standard ground shipping on most orders over \$149. Orders under \$149 will be charged shipping. Free shipping offer applies to the lower 48 U.S. states only. Alaska and Hawaii are subject to additional shipping fees. Oversized items that ship via truck freight may not be eligible for free shipping. If an order is placed for a truck freight item and there are additional shipping cost, a sales representative will contact you after your order with a shipping quote.

Shipping

If you are a first time Steeda customer, your order will be shipped to the billing address of your payment method.

Please allow one to two business days for orders to be processed. Standard shipping is FedEx Ground Indirect Signature Required to the continuous states, and FedEx 2nd day to Alaska, Hawaii and Puerto Rico unless otherwise requested. Shipping usually takes 3-7 business days depending on location. Options include FedEx Ground, FedEx 2Day (2 business days), FedEx Overnight (next business day), FedEx Freight Truck, UPS Ground, UPS 2nd Day Air (2 business days), UPS Next Day Air (next business day) and U.S. Mail. Orders will be shipped "signature required" unless other arrangements are made when the order is placed. Options include UPS Red (next day air), UPS Blue (2nd day air), U.S. mail, FedEx and Freight truck. Steeda gladly accepts international orders and ships parts world-wide. All customs fees and import duties are the responsibility of the purchaser. Some items must ship by truck due to size and weight. Shipping charges will be assessed when the order is placed.

Steeda's shipping department operates Monday through Friday. Because of this orders can not be shipped out on Saturdays or Sundays.

Free shipping offers do not apply to the state of Hawaii, Alaska or Puerto Rico. Free shipping offers typically ship via FedEx Ground, UPS, or USPS, unless otherwise noted.

Free shipping offers apply to non-truck freight items. If your items ships via truck freight, and there is an additional charge for shipping, you will be notified on the Cart page of checkout. You will then be notified by a Steeda Associate after you checkout to arrange shipping options.

Roll bars typically have a 4-6 week lead time and are custom built to order - these items are non-refundable.

Fiberglass Body Parts: Please inspect product before signing for delivery! Shipper & shipping company are not liable for damage that is not noted on the delivery receipt.

Orders placed before 12:00 PM EST for ground shipping should ship the same day unless it falls into the criteria below

- Shipping via freight
- Dropshipping
- Backordered
- Part of an assembled kit

International Shipping

We have partnered with a third party to service our international customers. Once you have created your shopping Cart, ensure the flag in the bottom right-hand corner of the screen is your country. If correct, click checkout in cart and you will automatically transferred to a page where you will be provided with international shipping costs. Upon completion of your order, your credit card will be charged for the entire purchase. We will ship the goods to the third party distribution facility where they will process the order and transport the goods to your international address. There are no additional fees or registration processes with this service. All customs fees and import duties on international orders are the responsibility of the purchaser.

Back Orders

Occasionally, we will temporarily be out of stock on an item. In these cases, partial shipments will be made and the back ordered item shipped at a later date, unless complete shipment is requested. You will be notified of unexpected delays.

Payments

Steeda accepts Visa, Mastercard, American Express, Discover, cashiers check, money order and personal checks. Allow 10 days for personal checks to clear. C.O.D. (cash on delivery) orders accepted on most items. Customer is responsible for shipping charges on refused C.O.D. orders. All customers who have refused C.O.D. orders in the past will be required to prepay future orders.

Should such parts prove defective following their purchase, the buyer and not the manufacturer, distributor or retailer, assumes the entire cost of all necessary servicing or repair.

WHAT IS NOT COVERED

The following items are not covered under the Limited Warranty:

- Incidental or consequential damages. Steeda is not responsible for any time for which you may lose the use of your vehicle, any inconvenience you might be caused, the loss of your transportation or any part thereof, or any other incidental or consequential damages you may have.

OTHER LIMITATIONS AND EXCLUSIONS

- Steeda reserves the right to inspect the vehicle and any parts removed from or installed in the vehicle in connection with any warranty claim or claim for damages. Steeda shall have no obligation to repair or replace any part unless the vehicle and affected part(s) have been made available for inspection.
- The performance of repairs or the replacement of the part(s) are the exclusive remedies under this warranty or any implied warranty. Steeda does not authorize any person to

create for it any obligation or liability in connection with parts or accessories sold by Steeda.

- Warranty does not cover cosmetic damage such as corrosion or rust.
- THE ONLY WARRANTY ON PARTS AND PRODUCTS SOLD BY STEEDA OR IN CONJUNCTION WITH REPAIRS OR INSTALLATIONS PERFORMED BY STEEDA ARE THOSE OF THE MANUFACTURER OR SUPPLIER OF SAID PARTS OR PRODUCTS. CUSTOMER RESPONSIBILITIES

- To obtain coverage pursuant to this Limited Warranty, the Customer must notify Steeda of any failure, malfunction or defect of the covered item(s) within 30 days of purchase. You must then return the part or accessory or vehicle to Steeda and authorize in writing all repair work to be performed by Steeda under this Limited Warranty.
- Any warranty claims on painted body components must be filed within 30 days of original purchase date; painted body component claims are not valid outside the 30 day window.

RETURNS

- In most cases, items shipped from Steeda can be returned within 30 days of purchase subject to the following terms and conditions.
- Upon receiving your order, immediately open the package(s) and inspect the contents. Should there be an issue with your order, please call us immediately. Whether we have made an error, or there is shipping damage, or you have a warranty claim, or you simply wish to do an exchange, do not return any product without first contacting us. All returns regardless of reason require a return authorization number and must be done within 30 days of purchase, excluding warranty returns for items still within their allowed warranty period.
- Returns without an authorization will be refused and return shipping charges will be the responsibility of the Customer.
- Items sold by Steeda but not manufactured by Steeda may require special handling. Warranty claims generally must be presented to the original manufacturer, defective Items must be returned within the manufacturer's warranty period, and special order items are not returnable or refundable. If you believe you have a defective item, please contact us first with your concerns as many times we can assist you in submitting a claim and help expedite the process. Please note that some manufacturers require a great deal of

information to accept a defective return. Consequently, please be prepared to provide specific information about your issues when you contact us for assistance.

- Items returned for a refund are subject to a 20% restocking fee. All returns for refund or exchange must be received in new, undamaged, and unused condition in the original boxes and properly packaged for us to receive in undamaged, sellable condition.
- Customers are responsible for return shipping fees - unless the product arrives defective or misshipped
- Items that have been installed are non-returnable.
- If a returned item is missing parts, or has been damaged through customer misuse, or has suffered shipping damage, the customer may be charged a higher restocking fee based on the condition of the product.
- If you are returning the item within the United States and the order is valued at \$100 or more, please insure the shipment for the value of the merchandise and ship your return with a signature shipping service. This protects you in case of shipping damage.
- If there is damage to your shipment, the shipping carrier must be contacted to file a damage claim. Please keep all packaging material and package contents as carriers typically return to inspect these items.
- All shipping related charges and fees are non-refundable.
- Once the returned item is received at Steeda, it could take up to 30 days to process the return and for the funds to show in your account.

LIMITATION OF LIABILITY
