

No compensation in MLS...but what does that include?

As you know, compensation fields have been removed from the MLS, as required of us by the settlement negotiated by NAR. But did you know that "MLS" does include ancillary tools that are part of your MLS membership.

Adding compensation information in any correspondence, confirmations, reports, or otherwise, in ShowingTime, SentriLock. Remine, Cloud Products or CRS Data is prohibited by NAR's settlement terms.



Not even ShowingTime? Not even ShowingTime. ShowingTime fields, instructions, or showing confirmation emails, to name a few, may not contain compensation information. **Any** communication or automated messages that you set up through ShowingTime may **not** include any compensation information, as part of the NAR-negotiated terms.



All of your MLS tools on the CHS MLS Launchpad are part of your MLS tool set, and may not include any compensation information. If in doubt, please don't hesitate to

What about fines?

We do have two new fines relating to NAR's new requirement that the MLS police the settlement terms of no compensation in the MLS, and the use of a buyer broker agreement.
