

The Anxiety Fix it Formula Privacy Policy and Terms & Conditions

IN CONSIDERATION OF THE MUTUAL PROMISES SET OUT IN THIS AGREEMENT, THE PARTY AGREES AND UNDERSTANDS THE FOLLOWING:

Refund Policy Option # 1: No Refunds

After the purchase of the Anxiety Fix it Formula is complete, there are no refunds provided. All payments must be made according to the payment schedule.

Lifetime or ongoing access policy:

You have ongoing access to the Anxiety Fix it Formula content hub. That means that after your program timeframe is complete, you will retain access to the content hub. After your program timeframe is complete, you will be removed from the program Facebook group and access to coaching will cease. NOTE: any unused 1:1 coaching calls will no longer be available for use after the program timeframe is complete.

Monthly payment plan policy:

If you are on a monthly payment plan, you are required to complete all of your monthly payments regardless of your activity in the Anxiety Fix it Formula program. Failure to complete your monthly payments may result in denied access to your content hub and coaching.

Declined payment policy:

As a client in the Anxiety Fix it Formula, you are required to complete all of your payments. You have 3 business days from the date of the payment decline to bring your account into good standing. Failure to bring your account into good standing may result in denied access to your content hub and coaching.

Friends & Family Discount Policy:

If you were to refer a friend or family member to the Anxiety Fix it Formula, you and your friend or family member who joins the Anxiety Fix it Formula, will receive an extra two weeks in the private Anxiety Fix it Formula, Facebook group which includes access to coaching. You will also be allotted two extra

weeks in the marco polo thread for Anxiety Fix it Formula. There is no monetary compensation or discount for referrals.

1:1 call cancellation, reschedule and no show policy:

The Anxiety Fix it Formula program requires 1 business day notice to cancel or reschedule a 1:1 coaching session. We understand that emergencies occur and will be treated on a case by case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have 1 opportunity to reschedule. If you do not show up for that rescheduled session you will forfeit the session and will be unable to rebook it. If this occurs two additional times you understand that you will be charged a \$50.00 fee.

1:1 Sessions Layout & Understanding

Lisashaultransformationcoaching will engage in direct, personal and confidential conversations with You in the Sessions. The nature of the Services may include discussions about personal aspects of your life, including but not limited to specific personal struggles, business matters, workplace issues, or general circumstances in your personal life. The Service may include value clarification, brainstorming, identifying plans of action, examining modes of operation in your life, asking clarifying questions, and making empowering requests or suggestions for action. Additionally, prayer may be involved in the Sessions and you may be asked to reflect on difficult topics or situations.

Method of Communication (Subject to Change)

The Sessions may be conducted via

1. Video sessions via Third-party platforms such as Facebook, Zoom, Google Meet, Skype or WhatsApp
2. Via phone call sessions (requiring quiet space with no interruptions)
