6. Speaker:
 - Brad Lussier: Greilach Lussier LLP – Changes to Capital Gains
 - o Proposed changes to capital gains as a result of the budget from Gov't of Canada
 - o A capital gain is the profit an individual or a business earns when they sell an asset, such as stocks or property.
 - o Proposal to increase capital gains inclusion rate (the portion on which tax is paid) from the current 50% (one-half) to 66% (two-thirds) This will result in an increase to the income that is recognized on capital gains by about 33%.
 - o Historically the rates have bounced around from 50%-75%
 - o On or after June 25, 2024 – the increase will take effect if proposal is passed
 - o For individuals the first \$250,000 will be at 50% inclusion rate and 66% for anything above \$250,000.00
 - o Corporation will be subject 66% for all capital gains
 - o Planning is key as this can result in a much larger tax payment for larger sales
 - o Capital gain exemption for small businesses shares and qualified farm property proposed to increase from 1MIL to 1.25MIL
