 - Encourages to keep youth in the local community

Three Funding Streams Available for Employers

- \$1,000 –Commitment to a minimum of 125 hours of on the job-training, membership and experience. Internship can be part-time or full-time. Internship must be completed by May 30.
- \$1,800 Commitment to a minimum of 240 hours of on the job training, mentorship and experience. Internship hours can be part-time or full-time
- \$3,600 Commitment to a minimum of 480 hours of on the job training, mentorship and experience. Internship hours can be part-time or full-time.
