- 8. Vote to Amend the Bylaws of the Chamber as follows:
 - to set out the terms of admission of members and the rights and obligations of members, to bring the bylaws into compliance with the Societies Act, RSA 2000, c S-14;
 - b) to require the financial statements presented at the AGM to set out the income, disbursements, assets, and liabilities of the Chamber, to ensure the financial statements prepared by the Chamber are in compliance with the *Societies Act*:
 - c) to allow for meeting of the members to be conducted virtually, and allow quorum to be reached by members attending meetings virtually;
 - d) to reduce the number of directors needed for a quorum from eight (8) to five (5); and
 - e) to set the minimum number of directors for the Chamber at nine (9) and the maximum number of directors at fifteen (15). The current minimum is twelve (12) and maximum is twenty (20).
 - Motion put forward by Megan to change the by-laws as above, second by Dave, all in favour

- a) Update membership fees for 2022
 - i. Non-profit no increase
 - ii. Business/Farm 1-3 employees increase from \$85 to \$95
 - iii. 3-5 employees increase from \$125 to \$135
 - iv. 6-20 employees increase from \$150 to \$165
 - v. 21+ employees increase from \$225 to \$250
 - vi. Silver, Gold and Platinum members no increase
- b) Proposal to offer a first-year reduction (50%) to fees for new small business to help them out and to help us grow our members
 - Motion put forward by Dave to update membership fees for 2022 and offer new small business fee reduction as per above, second by Randy, all in favour


