Calm The Chaos Method Policies

Refund Policy

In order to be eligible for a refund for the Calm The Chaos Method, you must provide the completed worksheets or show proof of action task completion for the first 2 modules in the program WITHIN 14 DAYS of completing your program transaction. You can email your fully completed worksheets or proof of action task completion to josipa@josipawellness.com. If you qualify for a refund and paid in full, a full refund will be provided within 7 business days. If you qualify for a refund and paid on a payment plan, your initial payment will be refunded within 7 business days and all future payments will be canceled.

Lifetime Or Ongoing Access Policy

You have lifetime access to the Calm The Chaos Method content hub. That means that after your 3-month program is complete, you will retain access to the content hub. After your 3-month program is complete, you will have an additional 6 months access to the program Facebook group and group coaching calls. After the 6-month period you will cease to have access to the FB group and group coaching calls. NOTE: any unused 1:1 coaching calls will no longer be available for use after the 3-month program is complete.

Monthly Payment Plan Policy

If you are on a monthly payment plan, you are required to complete all of your monthly payments regardless of your activity in the Calm The Chaos Method. Failure to complete your monthly payments may result in denied access to your content hub and coaching.

Declined Payment Policy

As a client in the Calm The Chaos Method, you are required to complete all of your payments. You have 5 business days from the date of the payment decline to bring your account into good standing. Failure to bring your account into good standing may result in denied access to your content hub and coaching.

1:1 Call Cancellation, Reschedule and No Show Policy

Calm The Chaos Method requires 24 hours notice to cancel or reschedule a 1:1 coaching session. We understand that emergencies occur and will be treated on a case by case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have 1 opportunity to reschedule. If you do not show up for that scheduled session you will forfeit the session and will not be able to rebook it.
