

**“Zombie Pack-A-Punch AR-15” Sweepstakes
(the “Sweepstakes”)**

**OFFICIAL RULES Purchasing a product will not increase your chances of winning.
NO PURCHASE NECESSARY TO ENTER OR WIN.**

1. SWEEPSTAKES DATES: The Sweepstakes begins at 2:00 p.m. Eastern Time (“ET”) on September 2, 2025 and ends at 11 p.m. ET on October 31, 2025 (the “Sweepstakes Period”). For purposes of these Official Rules, all times are given in Eastern Time.

2. ELIGIBILITY: Open to legal permanent United States residents of the forty-eight (48) contiguous United States and the District of Columbia (excluding New York) who are at least eighteen (18) years of age or older or nineteen (19) in Alabama and Nebraska and twenty-one (21) in Mississippi as of the date of entry (the “Entrant”). Employees, officers and directors of Dude Deals Inc (the “Sponsor”) and each of its subsidiaries and affiliates, distributors, vendors, advertising/promotion agencies, and any others engaged in the development, production, execution or distribution of the Sweepstakes, including, but not limited to, (the “Independent Administrator”), and the entities supplying the Grand Prize (collectively referred to herein as “Sweepstakes Entities”) as well as their immediate family members (spouses, siblings, children and parents, regardless of where they live) or members of the same households (whether related or not) of such employees, officers and directors are not eligible to participate. WINNING/ODDS: There will be one (1) random drawing held on or about October 15th, 2025 in which one (1) grand prize winner (the “Grand Prize Winner”) will be selected from among all eligible entries received during the Sweepstakes Period. Odds of winning the grand prize (the “Grand Prize”) will depend upon the total number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by Dude Deals Inc, whose

decisions are based upon its sole discretion and interpretation of these Official Rules and are final and binding in all respects.

5. NOTIFICATION: Potential Grand Prize Winner will be notified via e-mail within two (2) business days of the date in which the potential Grand Prize Winner is selected (the "Notification"). In order to claim the Grand Prize, the potential Grand Prize Winner must respond to the Notification within the time frame indicated by providing the Required Documents (as defined in the "PRIZE CLAIMS" section below). In the event that: (a) the potential Grand Prize Winner fails to respond to the Notification; (b) the potential Grand Prize Winner fails to supply the Required Documents; (c) any Notification is returned as undeliverable; and/or (d) it is determined by the Sponsor, in its sole discretion, that the potential Grand Prize Winner is not eligible in accordance with these Official Rules, such potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected at random from among all remaining non-winning eligible entries received during the Sweepstakes Period.

Grand Prize Winner must be eligible to possess a firearm and have a valid U.S. Driver's License Grand Prize Winner will be solely responsible for any applicable registration, license, or fees, all taxes (federal, state, local, sales and/or income) and any expenses not listed herein related to the acceptance and use of the Grand Prize. Sponsor and / or Independent Administrator are not responsible for lost, late, incomplete, incorrect, damaged, misdirected, or illegible entries or any condition caused by events beyond the control of the Sponsor that may cause the Sweepstakes to be disrupted or corrupted.
