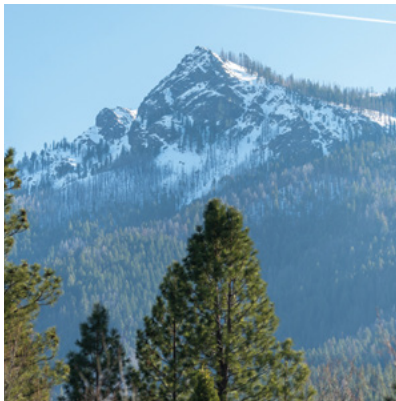

Hyperlinks: Business names, social icons, and email addresses are hyperlinked.

Search Function: If you’re looking for something specific, search the document using the ctrl F shortcut (hit “control” + “F” at the same time).

- For example, if you want to find vendors who service your community, hit “control” + “F”, then type in the name of your county and move between vendors who service your region.
- You can also skip straight to a specific vendor type before beginning your search to narrow down your results.

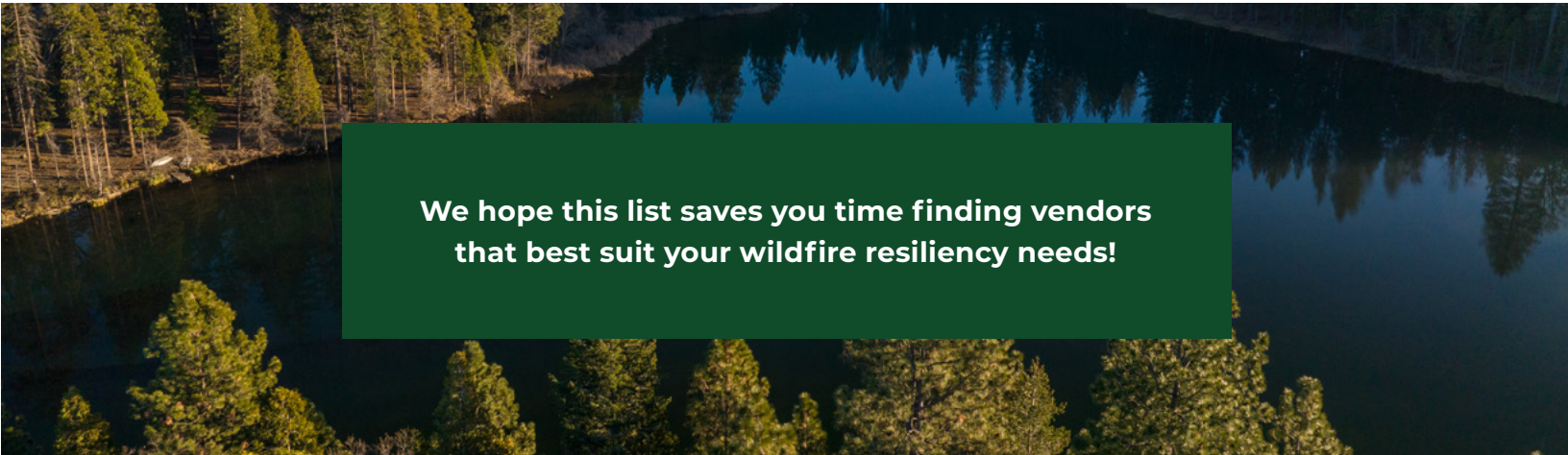
