

# EngageMore PRO

## AFFILIATE AGREEMENT

### 1. Introduction

This Affiliate Agreement ("Agreement") is entered into between ExposedAgent Marketing Solutions, LLC (dba EngageMore PRO) and the Affiliate. The purpose of this Agreement is to establish the terms and conditions under which the Affiliate will promote EngageMore PRO's services and receive a recurring payment for referrals that result in successful sales.

### 2. Affiliate Responsibilities

2.1. The Affiliate agrees to actively promote EngageMore PRO's services through their marketing channels.

2.2. The Affiliate will use only the promotional materials provided by EngageMore PRO, unless otherwise approved in writing by the Company.

2.3. The Affiliate will not engage in any deceptive, misleading, or unethical practices that might harm the reputation of EngageMore PRO.

### 3. Commission and Payment

3.1. The Company agrees to pay the Affiliate a recurring commission of 40% of the total revenue generated from customers referred by the Affiliate.

3.2. The commission will be calculated based on the net sales amount (not including set-up fees or bumps), excluding any refunds, chargebacks, and taxes.

3.3. Commissions will be paid on a recurring basis as long as the referred customer continues to use EngageMore PRO's services and pays for them.

3.4. Payments will be made on a monthly basis, within 60 days after the end of each calendar month, provided the minimum payout threshold of \$50 has been met. If the threshold is not met, the commission will roll over to the next month until the threshold is reached.

#### 4. Tracking and Reporting

4.1. EngageMore PRO will provide the Affiliate with a unique referral link and access to an affiliate dashboard to track referrals and commissions.

4.2. The Affiliate is responsible for ensuring that their referral link is used correctly to track sales.

#### 5. Term and Termination

5.1. This Agreement will commence on the Effective Date and will continue until terminated. Either party may terminate for any reason, without prior notice. Termination must be in writing via email.

5.2. EngageMore PRO reserves the right to terminate this Agreement immediately if the Affiliate breaches any terms of this Agreement or engages in conduct deemed harmful to EngageMore PRO.

#### 6. Confidentiality

6.1. The Affiliate agrees to keep confidential any proprietary information provided by EngageMore PRO, including but not limited to customer lists, business strategies, and financial information.

#### 7. Limitation of Liability

7.1. EngageMore PRO will not be liable for any indirect, special, or consequential damages arising in connection with this Agreement or the Affiliate's participation in the Affiliate Program.

## 8. Governing Law

8.1. This Agreement will be governed by and construed in accordance with the laws of the State of Arizona, without regard to its conflict of law principles.

## 9. Entire Agreement

9.1. This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements and understandings, whether written or oral, relating to its subject matter.

## 10. Amendments

10.1. EngageMore PRO reserves the right to modify the terms of this Agreement at any time. The Affiliate will be notified of any changes in writing, and continued participation in the Affiliate Program will constitute acceptance of the revised terms.
