

## **Privacy Policy**

This Privacy Policy ("Policy") applies to [www.impressivetransactionsolutions.com](http://www.impressivetransactionsolutions.com), and Impressive Transaction Solutions ("Company") and governs data collection and usage. ### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

The Company may also use your personally identifiable information to inform you of other products or services available from the Company and its affiliates.

### **Sharing Information with Third Parties**

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. ### **Tracking User Behavior**

### **Automatically Collected Information**

### **Security of Your Personal Information**

- SSL Protocol

We strive to take appropriate measures to protect against unauthorized access to or alteration of your personal information. ## **Right to Deletion**

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with certain state's Electronic Communications Privacy Act;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which the consumer provided the information.

## **Children Under Thirteen**
