Registration fees are due with application unless student(s) have a scholarship that will cover their entire tuition and fees. There will not be an annual supply/ book/ technology fee. A list of supplies needed for class will be given before the start of the school year. For your convenience, tuition will be broken down into 10 monthly payments (August-May). A 10% discount will be given to families that choose to pay the entire annual tuition and fees by the start of the 2023-2024 school year. Before and after care hours will be billed at \$3.50 per hour per child the following month after services were provided.

Additional Information

Monthly tuition will be billed on the first Monday of the month. Tuition/ fees are expected to be paid in their entirety within 10 business days. You must contact school administration if you can't pay your tuition on time. For any account that is more than 30 days late, LFMA reserves the right to suspend your student(s) until the account is brought current.

Any student withdrawn or dismissed after the first day of school will be charged for a full month for the month in which they attended. Registration fees are non-refundable.

Tuition and fees may be paid with a credit card, cash, or check. A fee of \$30 will be charged for any checks returned for insufficient funds by the bank. The returned check and fees must be paid within 5 business days.
