Refund Policy Option # 1: No Refunds

After the purchase of Empty Nest Solutions is complete, there are no refunds provided. All payments must be made according to the payment schedule.

Refund Policy Option # 2: Refund Provided.

In order to be eligible for a refund for Empty Nest Solutions, you must provide the completed worksheets or show provide of action task completion for the first 3 modules in the program BEFORE the 30 day mark of completing your program transaction. You can email your fully completed worksheets or proof of action task completion to lorigiancoaching@gmail.com. If you qualify for a refund and paid in full, a full refund will be provided within 7 business days. If you qualify for a refund and paid on a payment plan, your initial payment will be refunded within 7 business days and all future payments will be canceled.

Lifetime or ongoing access policy:

You have ongoing access to the Empty Nest Solutions content hub. That means that after your program timeframe is complete, you will retain access to the content hub. After your program timeframe is complete, you will be removed from the program Facebook group and access to coaching will cease. NOTE: any unused 1:1 coaching calls will no longer be available for use after the program timeframe is complete [omit this if you do not offer 1:1 client calls].

Monthly payment plan policy:

If you are on a monthly payment plan, you are required to complete all of your monthly payments regardless of your activity in Empty Nest Solutions. Failure to complete your monthly payments may result in denied access to your content hub and coaching.

Declined payment policy:

As a client in Empty Nest Solutions, you are required to complete all of your payments. You have 5 business days from the date of the payment decline to bring your account into good standing. Failure to bring your account into good standing may result in denied access to your content hub and coaching.

1:1 call cancellation, reschedule and no show policy:

Empty Nest Solution requires 1 business day notice to cancel or reschedule a 1:1 coaching session. We understand that emergencies occur and will be treated on a case by case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have 1 opportunity to reschedule. If you do not show up for that rescheduled session you will forfeit the session and will not be able to rebook it.

Hours Of Operation:

Empty Nest Solutions offers the following hours of operation: Monday – Friday, from 10:00 am ET to 8:00 PM ET . All client communication will be responded to within 1 business day or sooner during regular business hours. This includes responses inside of Empty Nest Solutions Facebook group.
