Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. THIS PROMOTION IS NOT SPONSORED BY, ENDORSED BY, ADMINISTERED BY OR OTHERWISE ASSOCIATED OR AFFILIATED WITH INSTAGRAM.

1. **Timing:** The ResortPass Daycation Giveaway (“Promotion”) begins on January 12, 2026, at 9 AM EST and ends on January 23, 2026, at 9 PM EST (the “Promotion Period”). **Administrator’s** computer is the official time keeping device for this Promotion.
2. **Eligibility:** The Promotion is open only to legal residents of the state of Florida who are at least twenty-one (21) years old at the time of entry. Employees of Administrator, Renaissance Orlando Resort and Spa, Insite Lake Buena Vista, LLC, Davidson Hotel Company, LLC d/b/a Davidson Hospitality Group, and any of their affiliate companies, as well as the immediate family (spouse, parents, in-laws, siblings, and children) and household members of each such employee are not eligible. Void where prohibited by law. The Promotion is subject to all applicable federal, state, and local laws and regulations. Participation in the Promotion constitutes entrant’s full and unconditional agreement to these Official Rules and by the Sponsor’s decisions, which are final and binding in all matters related to the Promotion. 3. **How to Enter:**

During the Promotion Period, log in to or create your Instagram account. Creating an Instagram account is free but is subject to Instagram's Terms of Use (<https://help.instagram.com/581066165581870#>).

To enter:

- Must follow Resort Pass (@resortpass) and Renaissance Orlando (@renaissanceorlando) on Instagram
- During the Promotion Period, visit <https://orlandohotelgiveaway.com/>. Complete all required fields on the Promotion entry form (including your first name, last name, email address, Instagram handle) and click “Submit”. Once you submit a complete entry form, you will receive one (1) entry into the Promotion.

In order for your entry to be valid, your Instagram profile must be public in order to be viewable by the Sponsor and its agents. If you do not have the Instagram App, you may download it through the application store on your mobile device. Message and data rates may apply. Please consult your wireless service provider regarding its pricing plans.
