I know there are a lot of options out there for accounting software, but Quickbooks has been my software of choice for all of my career. Quickbooks has made a lot of changes over the years. Just like everything else, technology has advanced. To stay current with technology, I have had to adapt to these changes and so will you.

I was a loyal Quickbooks desktop fan for MANY years and I did not want to make the change to online, but I finally gave in.

I will tell you, there are a lot of features with the online version that I really do like. I love being able to connect bank accounts and bring in feeds and set up memorized rules for transactions. And as an accountant and tax preparer, I LOVE it when my clients use Quickbooks online. It makes it so much easier to work on my client's files and help them.



## **What's the situation with Quickbooks Desktop?**

If you purchased Quickbooks 2020, as of May 31, 2023 you will need to update to Quickbooks Desktop 2023 and pay the annual subscription fee to have access to support and functions such as payroll. Or, you can switch to Quickbooks Online.

I know this can be frustrating. But let's help figure out what the best option is for you.

You can still get Quickbooks Desktop Premier in 2023, but you are now required to pay an annual subscription of \$799/year. I am not aware of a discount available on this option.

You can also get Quickbooks Desktop Enterprise. This version is for medium to large companies who need advanced inventory tracking, fixed asset management, and have multiple entities. Most small businesses do not need all the features of this desktop version. The annual subscription is \$1,410 per year (discount available).



## **Quickbooks Online**

There is a Quickbooks Self-Employed Version available, but I don't recommend it because you are better off to use a spreadsheet and not pay a subscription if this is all you are looking for. The Self-Employed version does not allow you to do double entry accounting and run financial reports. There is not a balance sheet with this version, so it doesn't show your assets, liabilities, and equity. This version would only be good if you have a Schedule C.

So I recommend you look over the different features of Simple Start, Essentials, Plus, and Advanced to see which version best fits your needs.

## Quickbooks Online Pricing

With any of these versions, I can get you the pricing listed as "Linda's Price" for your first 12 months, if you are a NEW user (or using a new email). Quickbooks often offers discounted pricing for three or six months, but my pricing will end up being better than what is offered on the Intuit website. Yes, I do receive a small commission, but you get the best pricing, so it is a win-win. Please just decide carefully because you can upgrade at any time, but if you upgrade, you will lose your discount. With any of the versions you have the option to add payroll.

If at any point you think you will be invoicing directly through Quickbooks, you will want to sign up for Quickbooks payments through my link now. Again, you will get the best pricing here rather than signing up directly through Intuit later.
