Privacy Policy and Terms & Conditions

PROGRAM POLICY

Refund policy:

After the purchase of The Pregnancy Preparation Program is complete, there are no refunds provided. All payments must be made according to the payment schedule.

Program timeframe:

The program timeframe is 12 weeks from your purchase date. Extensions may be granted by request based on the circumstances under which they are requested. To request a program timeframe extension, send an email to taryn@aubergineandolive.com noting the reason for your request.

Lifetime access policy:

You have lifetime access to the The Pregnancy Preparation Program content hub, so long as it remains in existence. That means that even after your program timeframe is complete, you will retain access to the content hub. However, after your program timeframe is complete, you will be removed from the program Facebook group and access to any coaching will cease.

Monthly payment plan policy:

If you are on a monthly payment plan, you are required to complete all of your monthly payments regardless of your activity in The Pregnancy Preparation Program. Failure to complete your monthly payments may result in denied access to your content hub and coaching.

Declined payment policy:

As a client in The Pregnancy Preparation Program, you are required to complete all of your payments. Should a payment be declined, you have 5

business days from the date of the payment decline to bring your account into good standing. Failure to bring your account into good standing may result in denied access to your content hub and coaching.

1:1 call cancellation, reschedule and no show policy:

The Pregnancy Preparation Program requires at least 48 hours notice to cancel or reschedule a 1:1 coaching session. We understand that emergencies occur and will be treated on a case by case basis. If you have a 1:1 coaching session scheduled and do not show up for your scheduled appointment, you will have one opportunity to reschedule. If you do not show up for that rescheduled session you will forfeit the session and will not be able to rebook it.

Hours Of Operation:

Aubergine & Olive offers the following hours of operation: Monday - Friday, from 9:00 am EST to 3:00 PM EST. All client communication will be responded to within one business day. This includes responses inside of The Pregnancy Preparation Program Facebook group.

Discount policy:

Aubergine & Olive does not offer discounts unless otherwise advertised during a specific promotional period. If the specific promotional period has ended, no discount will be offered.
