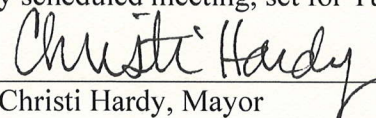

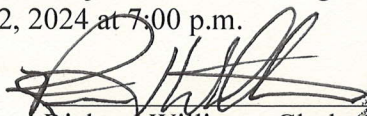

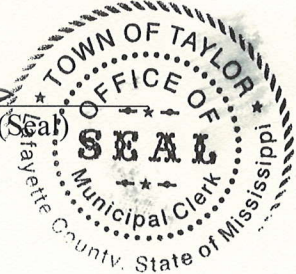
Alderman Sarah Hewlett Alderman Bill Taylor and Alderman Jimmie Willingham were
