This course was a block of instruction that was designed for law enforcement officers whose job responsibilities include investigation and reconstruction of traffic crashes. This course is a continuation of the Basic Occupant Kinematics for the Traffic



Crash Investigator course. The objective of this course is to give the officer a basic understanding of the forces required to produce certain fractures. After understanding how fractures occur, the officer can apply this knowledge to creating a path of travel of the occupant within the motor vehicle during the crash sequence.

Mechanics of injury in automobile crashes and air bag safety for first responders, Medical College of Wisconsin CIREN Center

This course was a block of instruction that was designed for first responders whose job responsibilities include initial response, pre-hospital medical care and extrication. This course was designed to give first responders an idea of mechanics of injury by looking at the damage pattern of a vehicle. This course also discussed the safety measures that need to be taken when encountering newer generations of supplemental restraint systems.

Mechanics of injury in automobile crashes and proper use of the Wisconsin Trauma Field Triage Guideline, Medical College of Wisconsin CIREN Center 08/2015

This course was a block of instruction that was designed for first responders whose job responsibilities include initial response, pre-hospital medical care and extrication. This course was designed to give first responders an idea of mechanics of injury by looking at the damage pattern of a vehicle. This course also discussed the proper field triage of patient as discussed in the field triage guidelines that were developed by the Wisconsin Department of Human Services, Emergency Medical Service Division.

This accident investigation course stresses evidence recognition, interpretation, and collection procedures. This course gives officers direction in serious traffic accidents and provides determination of how the accident occurred. This course gives officers the skills to collect and interpret the results of the accident and the knowledge to establish vehicle speeds, vehicle to roadway relationships and vehicle to vehicle relationships. This course also introduces students to traffic accident reconstruction principles that will help them establish these facts from certain kinds of skid mark evidence.
