

TERMS OF USE OF MUVONE

This “Terms of Use of muvone” (“**TOU**”) governs your use of the muvone platform (“**Platform**”), whereby you may book and test drive Used Vehicles (as hereinafter defined) before deciding whether to purchase the same.

You must register yourself and accept these TOU in order to use the Platform. By registering, accessing and/or using the Platform, you shall be deemed to have read, understood and agreed to be bound by these TOU (and such other terms and conditions and policies as may be referred to in these TOU). If you do not agree with any of these TOU, please immediately discontinue your access to and/or usage of the Platform.

A. MEMBERSHIP REGISTRATION

1. The application to be a member of the Platform (“**Membership Application**”) is **free of charge**.
2. Where you are:-
 - 2.1. An individual, you must be at least eighteen (18) years of age and is capable of entering into a legally binding agreement.
 - 2.2. a company, you must be a legally incorporated company in Malaysia.
3. During the application process, you may be required to provide us with accurate and complete personal information, including but not limited to your name, address, telephone number, email address and any other information as may be deemed necessary by us (“**Registration Information**”):-
 - 3.1. You shall be responsible to provide MUV with complete, accurate and updated Registration Information.
 - 3.2. MUV will process your Registration Information in accordance with the terms of our privacy notice, which can be access at from the website: www.muv-x.com (“**MUV’s website**”).
4. You shall be responsible for maintaining the confidentiality, security and use of your user ID and password (collectively, “**Log-In Credentials**”):-
 - 4.1. All instructions, confirmations, withdrawals, actions, acceptances or whatever representations or dealings that have been received by MUV via your account shall be binding on you, whether given by you or other persons purporting to be you. You shall be solely responsible to MUV for all activities that occur under your account.
 - 4.2. MUV shall not at any time be under a duty to verify the identity or authority of the person dealing with MUV apart from verifying the Log-In Credentials. You shall

be fully responsible for any accidental or unauthorized disclosure of your Log-In Credentials to any other person and shall bear the risk of any unauthorized usage of your Log-In Credentials.

- 4.3. If there has been any unauthorized access to your account, you shall notify MUV as soon as practicable. Until MUV actually receives such notification, you shall remain responsible for any access and all use of the Platform by the unauthorized person. MUV shall reserve the right to impose any administration fees in disabling and/or re-programming your Log-In Credentials.
5. MUV reserves the absolute rights and discretion to suspend and/or terminate your account in the Platform, if MUV determines or reasonably suspects that:
 - 5.1. you have violated any of these TOU;
 - 5.2. you have provided false information and/or documentation to MUV;
 - 5.3. you are or is reasonably suspected by MUV to be engaged in any unauthorized and/or dishonest and/or fraudulent account activity or behavior.
6. MUV shall not be liable for any damages of any type which may arise from your use of the Platform. You hereby agree to release, indemnify and keep indemnified MUV from and against all actions, claims, costs (including legal costs and expenses), losses, proceedings, damages, liabilities, or demands suffered or incurred by MUV to any person arising out of or in connection with:-
 - 6.1. your failure to comply with these TOU;
 - 6.2. your use of the Platform including but not limited to your use of the Used Vehicles during the Short Test Drive and/ or 3-Day Try/Buy.
7. Time, wherever mentioned in these TOU, shall be deemed to be of essence.
8. If any one or more of the provisions contained in these TOU is invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions hereof shall not be affected in any way or impaired thereby.
9. All notices, demands or other communications required to be given or made to MUV shall be made in writing and delivered by personal service, prepaid registered post or email at the address, facsimile and/or email address as set out hereunder (or to such other address and/or email address as may be notified by MUV to you from time to time):-

10. These TOU shall be governed by and interpreted in accordance with the laws of Malaysia. Any and all actions, disputes or controversies arising out of or in relation to these TOU and/or the use of the Platform shall be submitted to the exclusive jurisdiction of the court of Malaysia.

B. USE OF THE PLATFORM

1. Definitions

- 1.1. The second hand vehicles listed for sale in the Platform shall be collectively be referred to as the “**Used Vehicles**”, and the term “**Used Vehicle**” shall be construed accordingly.
- 1.2. MUV and you are collectively identified and known as “parties”.

2. Listing of Used Vehicles

- 2.1. All Used Vehicles available for booking, test drive and purchase are as listed in MUV’s website.
- 2.2. All Used Vehicles listed will be accompanied by photograph(s) and the relevant inspection summary, on a best-effort basis.
- 2.3. A Full Inspection Report of the Used Vehicle will be made available to you upon your request for the same, provided however that such Full Inspection Report will only be made available to a successful booker of the Used Vehicle under the 3-Day Try/Buy. Please refer to Clause 5 below in respect of the booking of the Used Vehicle.

3. Price of Used Vehicles

- 3.1. The prices of the Used Vehicles as listed on the MUV’s website are the **net** price (“**Car Price**”), **excluding** MUV’s service fees, road tax, insurance and all other taxes payable including but not limited to the sales and service tax or other similar governmental impositions and interests. The Car Price of the Used Vehicles on MUV’s website may be subject to change from time to time without any advance notice.
- 3.2. Price of Used Vehicles are open for negotiation (*oral and or written*) until a mutual price is agreed upon between parties.
 - 3.2.1. The final price of the Used vehicle upon negotiation shall be that as stated in the Buyer’s Order (“**Final Price**”). The Final Price shall be **inclusive** of MUV’s service fees amounting to **RM1,500.00** (or such other amount as may be revised by MUV from time to time), road tax, insurance and all

other taxes payable and shall override any previous oral/written discussion between parties.

3.2.2. There shall be no further negotiations on the price of Used Vehicles upon issuance of the Buyer's Order.

4. Physical Viewing of Used Vehicles

4.1. You may request for physical viewing of the Used Vehicles before test driving of the same.

4.2. Physical viewing of Used Vehicles are only available at MUV's Seri Kembangan Branch showroom @ Lot 3, Jalan 6/3 Kawasan Perindustrian Seri Kembangan, Selangor Darul Ehsan ("**MUV's Seri Kembangan Branch**") at the following days and time ("**Business Days and Hours**"), excluding public holidays for Selangor:-

Mondays to Fridays: 9:00a.m. to 5:00p.m.

Saturdays and Sundays: 10:00a.m. to 5:00p.m.

4.3. Physical viewing of Used Vehicles shall be subject to availability of the same.

5. Test Drive of Used Vehicles

5.1. You may have the following options in terms of the test driving of the Used Vehicles:-

5.1.1. 3-Day Try/Buy; or

5.1.2. Short Test Drive,

provided however, at any given time, you are only allowed to request and test drive pursuant to the 3-Day Try/Buy up to a **maximum of two (2)** Used Vehicles only ("**3-Day Try/Buy Limit**"). Upon reaching the 3-Day Try/Buy Limit, any subsequent test driving of the Used Vehicles shall be by way of Short Test Drive only.

3-Day Try/Buy

5.2. The 3-Day Try/Buy option allows you to book and test drive the preferred Used Vehicle of your choice for a period of three (3) days (*including day of receipt and return of the Used Vehicle*) or up to the distance of 300KM, whichever shall come first ("**3-Day Try/Buy**").

5.3. All Used Vehicles will be made available for a 3-Day Try/Buy subject to availability of the relevant Used Vehicles at the time of your booking.

5.4. For the avoidance of doubt, the 3-Day Try/Buy shall **not** be available to any

person who:-

- 5.4.1. does not possess a valid local Malaysian driving license or, in the case of a non-Malaysian, a valid international driving license/ permit; and/or
 - 5.4.2. has been convicted of serious traffic offences, including but not limited to driving under the influence of alcohol, intoxicants or other drugs (or such other offences as MUV may in its absolute discretion deem appropriate). By submitting a request to book for the 3-Day Try/Buy to MUV, you hereby agree and consent to the use of your personal data by MUV for purposes of verification of your traffic offence record.
- 5.5. Any booking for a 3-Day Try/Buy of the Used Vehicles may be made via either one of the following options:-

5.5.1. Online booking via MUV's website:-

5.5.1.1. You are required to be a registered member of MUV's website/ Platform.

5.5.1.2. At the time of booking, you will be required to:-

- (a) select your preferred Used Vehicle;
- (b) key in complete details of address to which the selected Used Vehicle shall be delivered (*if applicable*, please see Clause 5.8 below);
- (c) select the intended purchase method: either via cash (which shall include payment by way of telegraphic transfer and or cheque) or via financing (please see Clause 5.7 below);
- (d) pay the requisite deposit (please see Clause 5.6 below).

(collectively, the "**Conditions Precedent**")

5.5.1.3. Subject always to Clause 5.4, a digital booking confirmation will be sent to your email address upon your fulfillment of the Conditions Precedent **provided however** that in the case of a financing buyer, you shall be required to comply with the additional requirements under Clause 5.7, failing which you shall not be allowed to proceed with the 3-Day Try/Buy and your booking shall be cancelled by MUV.

5.5.2. Booking in person at MUV's Seri Kembangan Branch:-

5.5.2.1. Booking for the 3-Day Try/Buy may also be made over the counter at MUV's Seri Kembangan Branch. In this instance, MUV's personnel will assist you in the registration of an account under the Platform. The request shall be accompanied by a copy of the following documents:-

- (a) Your Identity Card/Passport; and
- (b) Your driving license.

5.5.2.2. At the time of request you shall also:-

- (a) notify MUV's personnel of the preferred Used Vehicle;
- (b) provide details of address to which the selected Used Vehicle shall be delivered (*if applicable*, please see Clause 5.8 below);
- (c) provide details of intended purchase method: either via cash (which shall include payment by way of telegraphic transfer and or cheque) or via financing (please see Clause 5.7 below);
- (d) make payment of the requisite deposit (please see Clause 5.6 below).

(collectively, the "**Conditions Precedent**")

MUV's personnel will assist you in key-ing in the above information for purposes of the booking.

5.5.2.3. Subject always to Clause 5.4, digital booking confirmation will be sent to your email address (or where email address is not available, a hardcopy of the official receipt issued by MUV to you in respect of the deposit paid will be treated as an equivalent of the booking confirmation) upon your fulfillment of the Conditions Precedent to MUV's satisfaction **provided however** that in the case of a financing buyer, you shall be required to comply with the additional requirements under Clause 5.7, failing which your booking shall be cancelled by MUV.

5.5.3. Notwithstanding the above:-

5.5.3.1. In processing your booking request, MUV reserves the absolute discretion to request for such other information

and/or documents from you (including but not limited to pay slips and bank statements) for any reason (“**Additional Request**”), and the failure by you to comply with such Additional Request may result in your booking request being rejected.

- 5.5.3.2. It shall be the sole discretion and right of MUV to reject your request for a 3-Day Try/Buy for any reason as it may deem fit.
- 5.5.3.3. You may withdraw the booking request at any time before the 3-Day Try/Buy appointment date.
- 5.5.3.4. In the event of any rejection or withdrawal of your booking request, MUV will refund the deposit to you within five (5) working days of the said rejection or withdrawal.

5.6. Deposit payment:-

- 5.6.1. A deposit payment is a pre-requisite and shall be made in order for you to effectively submit the 3-Day Try/Buy booking (“**Deposit**”).
- 5.6.2. The applicable rates of Deposit for the Used Vehicles are as follows:-

Price	Deposit Required
Less than RM30,000.00	RM1000.00
Between RM30,000 to RM50,000.00	RM2000.00
More than RM50,000.00	RM3000.00

5.6.3. The Deposit payment may be made as follows:-

- 5.6.3.1. FPX online payment gateway (in which case your use of the payment gateway shall also be subject to such terms and conditions as may be stipulated by the respective vendor);
- 5.6.3.2. Credit card (in which case your use of the credit card shall also be subject to such terms and conditions as may be stipulated by the respective bank and/or card association);
- 5.6.3.3. Cash; or
- 5.6.3.4. Cheque (made payable to “**MUV MARKETPLACE SDN.BHD**” at its Maybank account, at account no.

514561325827);

Proof of payment of the requisite Deposit shall be provided to MUV for the issuance of the booking confirmation to you.

5.7. Loan documents (for loan buyers):-

5.7.1. In the event where you have indicated your intention to purchase the preferred Used Vehicle by way of financing, it shall also be a pre-requisite for you to obtain a pre-approved loan granted in your favor for the purchase of the preferred Used Vehicle within five (5) working days from the date of MUV's issuance of the booking confirmation, failing which you shall not be allowed to proceed with the 3-Day Try/Buy and your booking shall be cancelled by MUV. Evidence of grant of the pre-approved loan may be submitted to MUV in either hardcopy or softcopy.

5.7.2. You may apply for the relevant loan from any one of MUV's list of available financial institutions. MUV may, upon your request, assist in the loan application, in which case:-

5.7.2.1. You hereby agree and authorize MUV to communicate with your preferred financial institutions for the purposes of obtaining loan approval and/or ascertaining progress of the loan application.

5.7.2.2. you shall promptly provide MUV with such documents as may be necessary for the loan application, including but not limited to the following:-

Where you are an individual (local or permanent resident):-

- (a) a copy of your national registration identity card (“**NRIC**”);
- (b) a copy of your driving license;
- (c) a copy of your pay slip for the past three (3) months;
- (d) a copy of your bank statement for the past three (3) months; and
- (e) a copy of your Employee Provident Fund statement.

Where you are an individual (being a foreigner):-

- (a) a copy of your passport;
- (b) a copy of your employment letter and working visa;

- (c) a copy of your pay slip for the past three (3) months;
- (d) a copy of your bank statement for the past three (3) months; and
- (e) a guarantor who shall be a Malaysian citizen will be required.

Where you are a sole proprietorship/ partnership:-

- (a) a copy of the sole proprietor or partner's NRIC who will be executing the loan documents;
- (b) a copy of the business registration certificate and business renewal certificate (where applicable);
- (c) A copy of the business's saving or current account statement reflecting the business's past three (3) months' declared income;
- (d) A copy of your latest income tax statement with proof of tax payment.

Where you are a company (whether private or public):-

- (a) A copy of a director's NRIC;
- (b) A copy of certificate of incorporation of company(Form 9), Form 24 & Form 49;
- (c) A copy of the company's document of constitution;
- (d) A copy of the company's Board of Directors' Resolution for the purchase of the Used Vehicle;
- (e) A copy of the company's current account statement reflecting the company's past three (3) months' declared income; and
- (f) A copy of the company's latest financial statement.

- 5.8. Within five (5) days upon MUV's issuance of the booking confirmation to you (and where applicable, subject to your fulfillment of the requirements under Clause

5.7), MUV will notify you of the availability of the Used Vehicle for 3-Day Try/Buy. You may then collect the Used Vehicle from MUV's Seri Kembangan Branch, or where the delivery option has been selected at the time of your submission of the booking request ("**Delivery Option**"), MUV will deliver the Used Vehicle based on the address provided by you in your booking request:-

5.8.1. Please consult MUV for the list of areas within which the Delivery Option is available. Alternatively, you may visit MUV's website for the list of available areas.

5.8.2. If the Delivery Option is not available at your area of request, you shall at your own cost and expense arrange for self-collection of the preferred Used Vehicle from MUV's Seri Kembangan Branch.

5.8.3. Where the Delivery Option is available, the delivery date and time of the preferred Used Vehicle to you for the 3-Day Try/Buy will be agreed between MUV and you.

5.8.4. Any authorization for a 3rd party to collect the preferred Used Vehicle on your behalf shall be made in writing and informed in writing to MUV, in advance prior to the collection or delivery date (*whichever is applicable*).

5.8.5. Notwithstanding the above, MUV retains full discretion to accept or reject your request for the Delivery Option and may suggest alternative method(s) of collection of the preferred Used Vehicle by you, as MUV deems necessary.

5.9. During the duration of the 3-Day Try/Buy period:-

5.9.1. the Used Vehicle will be digitally monitored by MUV via the use of a telematics device:-

5.9.1.1. The data which may be collected from the telematics device will include but not limited to, mileage travelled, violation reports (speeding, hard braking, fast acceleration, rough driving etc.), active duration, idle duration and location of the Used Vehicle.

5.9.1.2. You shall not, and shall not permit any person to, tamper or otherwise modify or adjust or dismantle the telematics device or any part thereof. In the event any re-installation or reconfiguration of the telematics device is required due to the unauthorized tampering, modification, adjustment or dismantling, MUV shall reserve the right to offset such expenses as may be incurred by it from the Deposit, and in the event where the Deposit is insufficient, to claim for such excess amount against you.

5.9.2. You shall comply with such terms of use of the Used Vehicle as may then be stipulated by MUV.

You be solely liable and shall indemnify MUV from and against all damages, liabilities, costs, expenses (including, without limitation, reasonable legal fees), claims or judgment that arise out of or results primarily from your use of the Used Vehicle during the 3-Day Try/Buy

5.10. Return of the Used Vehicle:-

5.10.1. The 3-Day Try/Buy is strictly limited to three (3) days only (*including day of delivery/collection and day of return*), and the Used Vehicle shall be returned to MUV on the third (3rd) day of the 3-Day Try/Buy at MUV's Seri Kembangan Branch within the Business Days and Hours.

5.10.2. You may request for the preferred Used Vehicle to be collected from you at the end of the 3-Day Try/Buy ("**Collection Option**"). Please consult MUV for the list of areas within which the Collection Option is available. Alternatively, you may visit MUV's website for the list of available areas.

5.10.3. If the Collection Option is not available at your area of request, you shall at your own cost and expense arrange for delivery of the preferred Used Vehicle to MUV's Seri Kembangan Branch.

5.10.4. Notwithstanding the above, MUV retains full discretion to accept or reject your request for the Collection Option and may suggest alternative method(s) of return of the preferred Used Vehicle by you, as MUV deems necessary.

5.11. The Used Vehicle shall be returned to MUV in the same condition and fuel tank level as it was during the collection or delivery of the same to you (*whichever is applicable*). Failing which, MUV may deduct the relevant amount from your Deposit, including such costs as may be incurred by MUV to repair any damage caused to the Used Vehicle during the 3-Day Try/Buy, and in the event where the Deposit is insufficient, MUV shall be entitled to claim for such excess amount against you..

5.12. Without prejudice to such other remedies as may be available to it, MUV shall be entitled to impose a penalty upon you in respect of the following wrongdoings ("**Penalty**"):

Description	Penalty Amount
Exceeding mileage allowance of 300KM	RM0.70/KM
Late return of the Used Vehicle	RM200/per day
The Used Vehicle is returned in less than the fuel tank level as when it was first provided	Prevailing fuel rate.

Smoking within the Used Vehicle	RM200
Lost car keys	Case by case basis, at an amount to be determined by MUV at its discretion
Any new dent, scratch, or external/ interior damage on the Used Vehicle	Case by case basis, at an amount to be determined by MUV at its discretion
Traffic/ Parking violations	As per the local council's charges
Where extensive cleaning of the Used Vehicle is required	Case by case basis, at an amount to be determined by MUV at its discretion

MUV reserves its right to offset and/or deduct the Penalty from the Deposit, and in the event where the Deposit is insufficient, to claim for such excess amount against you.

Short Test Drive

- 5.13. In the event where the 3-Day Try/Buy is not available to you for any reason whatsoever, you may opt for the short test drive option, whereby you will be able to test drive the preferred Used Vehicle at the designated route accompanied by MUV's personnel ("**Short Test Drive**").
- 5.14. All Used Vehicles will be made available for a Short Test Drive subject to availability of the relevant Used Vehicles at the time of your request.
- 5.15. Any request for a Short Test Drive may be made over the counter at MUV's Seri Kembangan Branch. The request shall be accompanied by a copy of the following documents:-
 - 5.15.1. Your Identity Card/Passport;
 - 5.15.2. Your Driver's License; and
 - 5.15.3. Such other document(s) as may then be required by MUV.
- 5.16. You shall strictly comply with any instruction(s) as may be given by MUV's personnel during the course of the Short Test Drive. Any non-adherence to MUV's personnel's instruction(s) during the Short Test Drive:-
 - 5.16.1. Allows MUV's personnel to immediately and unilaterally terminate the Short Test Drive arrangement between parties; and
 - 5.16.2. Allows MUV's personnel to take control of the relevant Used Vehicle from

you.

5.16.3. You may be subject to charges and or liabilities as per the applicable laws and regulations in Malaysia and or this TOU, initiation of which shall be at the full discretion of MUV.

5.17. You shall indemnify MUV in respect of any losses, damages, costs, liabilities, actions which may be suffered by MUV as a result of:-

5.17.1. any persona injury, death, property damage (including but not limited to damage to the Used Vehicle) caused by you; and/or

5.17.2. Your failure to comply with the applicable laws and/or instructions of MUV's personnel,

during the course of the Short Test Drive.

6. Confirmation of Purchase/Non-Purchase of Used Vehicle

6.1. Upon the completion of the 3-Day Try/Buy and/or the Short Test Drive and at the time of surrendering the Used Vehicle to MUV or collection of the Used Vehicle by MUV (*whichever is applicable*), you shall inform MUV of your intention to purchase the preferred Used Vehicle or otherwise, failing which:-

6.1.1. You shall be deemed to have decided not to proceed with the purchase of the Used Vehicle, and the Used Vehicle will then be made available for viewing, booking, test driving and purchase by others;

6.1.2. MUV will proceed with its internal process to refund the Deposit to you within five (5) working days, subject to any set-off and/or deductions as may be made pursuant to these TOU.

7. Confirmation of Purchase; Payment

7.1. Upon your confirmation of your intention to purchase the Used Vehicle, you shall be required to complete and sign the following documents:-

7.1.1. A Buyer's Order, whereby the Final Price for the Used Vehicle as agreed between the parties will be stated; and

7.1.2. In the event where the purchase of the Used Vehicle is by way of financing, the hire purchase agreement and such other documents as may be required by the relevant financial institution.

7.2. Payment of the Final Price:-

7.2.1. For cash buyers:-

- 7.2.1.1. In cases of 3-Day Try/Buy, the Deposit (or the remaining portion thereof) will be used towards the part payment of the Final Price.
- 7.2.1.2. The balance of the Final Price shall be settled **within five (5) working days** from the date of your execution of the Buyer's Order.
- 7.2.2. For loan buyers:-
 - 7.2.2.1. The loan for the purchase of the Used Vehicles will be up to a maximum of 90% of the Final Price only.
 - 7.2.2.2. The remaining 10% of the Final Price shall be treated as down payment for the Used Vehicle ("**Down Payment**") and shall be paid by you to MUV within five (5) working days from the date of your execution of the Buyer's Order.
 - 7.2.2.3. In cases of 3-Day Try/Buy, the Deposit (or the remaining portion thereof) will be used towards the part payment of the Down Payment. The balance of the Down Payment (*if any*) shall be paid by you to MUV within five (5) working days from the date of your execution of the Buyer's Order.
- 7.2.3. In the event of your failure to comply with the payment obligations as stipulated above, MUV reserves the absolute discretion to:-
 - 7.2.3.1. Terminate the Buyer's Order;
 - 7.2.3.2. properly dispose and/ or make available the selected Used Vehicle for other potential buyers; and
 - 7.2.3.3. forfeit the Deposit in entirety.
- 7.2.4. To the extent your purchase of the Used Vehicle (whether by cash or otherwise) is subject to the sales and service tax or any other similar governmental impositions and interests ("**Taxes**"), you shall bear such Taxes and shall indemnify MUV and keep MUV fully indemnified at all times in respect of your breach of obligation hereto.
- 7.3. Trade in option:-
 - 7.3.1. You may opt to trade in your vehicle(s) with MUV ("**Trade In Vehicle**") as part payment of the Final Price for the Used Vehicle.
 - 7.3.2. The Trade In Vehicle shall be subject to MUV's appraisal and valuation,

and it is the sole discretion of MUV whether to accept or reject the Trade In Vehicle.

7.3.3. Upon agreement of all parties to the trade in value of the Trade In Vehicle (“**Trade In Value**”), the Trade In Value shall be deducted from the Final Price of the Used Vehicle and subsequently reflected in the revised Buyer’s Order.

7.3.4. You shall ensure that the Trade In Vehicle is delivered to MUV’s Seri Kembangan Branch, together with such documents as may be necessary for its transfer of ownership to MUV (e.g. the vehicle ownership certificate of the Trade In Vehicle), during collection of the Used Vehicle from MUV.

8. Cancellation of purchase; Refund

8.1. In the event of your cancellation of purchase after signing of the Buyer’s Order, the Deposit shall be forfeited by MUV.

8.2. There shall be **STRICTLY NO REFUND** in respect of the Used Vehicle(s) purchased by you via the Platform.

9. Insurance

9.1. At the time of purchase of the Used Vehicle, it shall be compulsory for the Used Vehicle to be insured in accordance with the applicable laws, regulations and requirements of Malaysia. You shall obtain the necessary insurance for the purchase of the Used Vehicles only from MUV at your own costs and expense.

9.2. The costs of the insurance will be included in the Final Price of the Used Vehicle and will be reflected in the Buyer’s Order.

10. Warranty

10.1. For the avoidance of doubt, the Used Vehicles on the Platform are sold strictly on an “**AS IS WHERE IS**” basis, and MUV does not provide any warranty whatsoever in respect of the Used Vehicles. All implied terms and warranties are, to the maximum extent permissible by laws, hereby excluded. All implied warranties under the **Sale of Goods Act 1957 (Act 382)** are also specifically and expressly excluded.

10.2. You may purchase an extended warranty for the purchased Used Vehicle (“**Extended Warranty Package**”) from any one of MUV’s list of available insurers, including but not limited to MyOpal Services or AmGeneral Insurance Berhad (“**Insurers**”) at your own expense & costs, and subject to such terms and conditions as may be stipulated by the respective Insurers.
