2022 Election Results

- Board of Trustees
 - Incumbent Bill Sandiford was re-elected
 - Rob Seastrom and Hank Kilmer are newly elected members
- Advisory Council
 - Incumbents Alison Wood and Brian Jones were re-elected
 - Gerry George, Kendrick Knowles, and Gus Reese are newly elected members
 - Douglas Camin was also appointed for a one-year term to fill the seat Rob Seastrom vacated - effective 1 January - to join the Board
- NRO Number Council
 - Nick Nugent was elected to a seat on the NRO NC from the ARIN region

Routing Security

Automatic re-roll of RPKI objects (ROAs) - First half 2023

• Eliminate impact of untimely expiration

New Routing Dashboard - Second Half 2023

- Create / Delete multiple ROAs in one action ARIN Online UI and API
- Preview changes of ROA actions / resulting RPKI validity state
- Summary of resource announcements in BGP table
- State of existing ROAs / recommendations for new ROAs
- Automatic IRR route object creation at ROA generation
- New options for notification of RPKI changes

Automating ticketed processes to reduce RSD load - Second Half 2023

- Request resource certificate Hosted or Delegated signup
- Return to ROA creation page after last create action
- Give Org control to delete RPKI certificates switch RPKI deployment types



2FA Services Update

- SMS was implemented 25 August 2022
- TOTP continues to be active and available
- Preliminary data (8/25-12/31, 2022) is positive with a significant jump in new 2FA customers (5,157) since 8/25 announcement across TOTP and SMS
 - 66.6% were TOTP activations
 - 33.4% were SMS
- FIDO2 was deployed 3 January
 - ~100 sign-ups in January
- 2FA mandatory on 1 February



IPv6: Helping Your Organization Grow



- Fees are minimal
- Provides a much larger address pool so more devices can be connected to the Internet
- Improves addressing and routing of network traffic




IPv4 Waitlist

ARIN Fee Cap Update

Expiration of annual fee cap

Beginning 1 January 2024, no fee cap will be offered on annual fees for organizations seeking to bring legacy resources under an LRSA

Organizations that have the fee cap will continue to benefit from the fee cap for legacy resources brought under an LRSA before 1 January 2024



ARIN Community Grant Program



- Application site opens in April 2023
- Four categories project must fit into:
 - Internet technical improvements
 - Registry processes and improvement
 - Informational outreach that advances the Internet
 - Research related to ARIN's mission and operations
