On motion of Ms. Eato-White, seconded by Ms. Soto, the board approved the minutes from the March 2024 regular board meeting. Vote: 3 - yes, 0 - no, 0 - abstain, 2- absent.

Executive Director's Report

Mr. Karon reported on the Performing Arts Garage, the T2 system is now fully functioning in place to monitor access into the garage. The garage now offers Pay by Text, the feature has been a popular addition to pay for parking at the facility.

Mr. Karon reported on TIBA PARCS, the installation at the Wellness Garage has been held off until all groups that validate parking in that area have a complete understanding of the new web validation system. The proposed installation date will be the week of June third.

Mr. Karon reported on restorations and maintenance for the facilities, they have received bids for the restoration work at Civic, Morris, Church, and Paterson St Garages. The low bid was submitted by Sealcrete, they have done satisfactory work in the past for NBPA. Mr. Karon has a resolution to approve their bid and hoping to start work in June.

Mr. Karon reported on Enforcement, due to the tremendous increase in food delivery services and vehicles, they are finding many vehicles stopping or parking illegally within the downtown area. To address this problem, Mr. Karon is proposing an ordinance change to numerous loading zones in the SID to allow for 10 minutes drop off and pick up parking between the hours of 4:30 PM and midnight and from 2:00 PM to midnight on Saturdays, Sundays, and holidays. This will hopefully give the drivers a legal area to park while they are servicing their customers.

In an effort to stimulate parking turnover, Mr. Karon is also requesting that the remaining loading zones in the downtown area be monetized from 4:30 PM until 10:00 PM Monday through Friday and from 2:00 PM until 10:00 PM Saturday, Sunday, and holidays. These areas will use ParkMobile and Pay by Text to pay for parking time. All other meters will be enforced until 10:00 PM. Elm Row, which is a special parking district that requires an official placard to park there during weekdays will be available for public parking from 5:00 PM till 10:00 PM Monday through Friday, 8:00 AM till 10:00 PM Saturdays and 1:00 PM till 10:00 PM Sundays.
