#### Minutes of a Regular Board Meeting August 4, 2021

A regular meeting of the New Brunswick Parking Authority was held on August 4, 2021, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. Chairman Kevin McTernan called the meeting to order at 5:00 p.m.

Mr. McTernan read the public statement of meeting on adequate notice as required by P. L. 1975.

#### **Minutes**

On motion of Mr. Keefe, seconded by Mr. Garlatti, the board approved the May 2021 regular board meeting minutes. Vote: 4 - yes, 0 - no, 1 - absent (Eato-White), 0 - abstain.

#### **Executive Director's Report**

Mr. McTernan welcomed Mr. Matthew Kennedy as executive director.

Mr. Kennedy expressed appreciation and gratitude to all board members and staff and noted that it was the first in-person board meeting since the start of the pandemic.

Mr. Kennedy stated that revenues have begun to recover in June and July. After not filling to capacity a single time since the onset of the pandemic, Lower Church Street Deck filled to capacity three times in the second half of the month of June and filled eight times in July. Last week, for the first time in 2021, the total year-to-date parking revenue exceeded the parking revenue collected during the same period last year.

The NBPA in July provided the City of New Brunswick with the first half of the 2021 PILOT and will be making the second half payment in December, in accordance with the regular PILOT payment schedule.

At the end of this month, the NBPA will make its regular midyear payment of bond principal and interest.

Although the NBPA website already listed the names of the authority's employees, the NBPA recently added each employee's job title to the list of names on the website.

The NBPA currently has 41 employees. This includes four rehires since January 2021, including three who had been laid off due to the pandemic.

The NBPA currently is seeking to hire one customer service position for the office, one parking enforcement officer, and one or more parking services team members.

#### **Finance**

Mr. Rajaratnam stated that the NBPA still is awaiting a report from the state in order to complete the NBPA's 2020 audit.

#### **Public Comment**

A member of the public, Charles Kratovil of New Brunswick, welcomed Mr. Matthew Kennedy to the city.

Mr. Kratovil asked if the board had any comment on the cyberattack against ParkMobile. The board advised that Mr. Kennedy would look into the matter and report back to Mr. Kratovil.

Mr. Kratovil asked the board to confirm the total debt of the NBPA. Mr. Kennedy stated that the total bond amount is currently \$231,460,000. He noted that, by the end of the month, after the next bond payment is made, the total bond amount would be \$227,340,000.

Mr. Kratovil asked if there was any update on the former Ferren site. Mr. McTernan advised him to ask DEVCO.

Mr. Kratovil asked if the executive director could speak to what he sees as the biggest challenges the parking authority faces at this point. Chairman McTernan responded that the biggest challenge for the NBPA post-pandemic is to regain some of the revenue lost during the pandemic so that the NBPA can continue to serve the citizens, parkers, and residents of New Brunswick as well as possible.

#### **Board Discussion**

#### Resolutions

On motion of Mr. Keefe, seconded by Mr. Garlatti, the board approved the Payment Resolution for August 2021.

\*Mr. Caputo briefly stepped out of the room prior to the vote being taken.

On motion of Mr. Garlatti, seconded by Mr. Keefe, the board approved the Resolution Approving a Settlement Agreement with KBG Express NB LLC.

Vote: 4 - yes, 0 - no, 1 - absent (Eato-White), 0 - abstain.

The tenant at 6 Easton Avenue, a restaurant, fell behind on rent payments from April 2020 – May 2021. This settlement agreement stipulated that the tenant must pay 75% of the full balance due for that time period within five days of the board's approval of the settlement agreement.
