Board Meeting Minutes January 29, 2025

A regular meeting of the New Brunswick Parking Authority was held on January 29, 2025, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. Chairman Kevin McTernan called the meeting to order at 5:09 p.m.

Chairman Kevin McTernan read the public statement as required by P. L. 1975.

On motion of Ms. Soto, seconded by Mr. Sleiman, the board approved the minutes from the December 2024 regular board meeting. Vote: 5 - yes, 0 - no, 0 - abstain, 0- absent.

Executive Director's Report

Mr. Karon reported update on the 2025 Restoration, stating that due to a technical error, the bid opening for the 2025 restoration work has been postponed to February 5th, from the originally scheduled date of January 16th.

Mr. Karon reported insurance coverage, noting that as per the resolution to be passed that evening, the Authority will be switching its insurance coverage to Mid Jersey JIF, effective January 1 of this year. This change was necessary due to the dissolution of the Middlesex County JIF. Any new claims will be processed through Mid Jersey JIF, while outstanding claims prior to January 1 will continue to be handled by the Middlesex County JIF.

Mr. Karon reported on the Church Street Garage, explaining that the Authority will be replacing the PARCS equipment at this facility, with the next installation being TIBA equipment. He noted that the Wellness Garage was the first facility to switch to TIBA, and the transition has been successful, with the equipment running smoothly. He emphasized that the Authority's goal is to gradually replace its aging revenue control equipment over the next few years.

Mr. Karon reported on the snow parking event from Sunday, January 19, 2025, at 10:00 AM to Monday, January 20, 2025, at 8:00 AM. He shared the number of snow parkers in each facility: 13 at Morris St. Deck, 3 at New St. Deck, 6 at Plum St. Deck, and 3 at Wellness Deck, totaling 25 snow parkers altogether.

Public Comment

A member of the public inquired about the meeting schedule for the year and how many meetings would be held. Mr. Karon stated that there will be 6 meetings for the year.

A member of the public inquired about remote meetings as a suggestion to make it easier for the public to attend. They also mentioned that it might be a good idea to include public comments during reorganization meetings, something to keep in mind for the future.

A member of the public inquired about the enforcement officers, asking if the 9 officers we currently have is the most we've ever had at the Parking Authority. Mr. Karon stated, yes, we now enforce the meters until 10 PM and enforce on Sundays.

A member of the public inquired about the Joint Insurance Funds (JIF), expressing concerns about their stability. The member wanted to know how the Parking Authority settled on the new JIF, why they decided to join it, and what other options were considered. Mr. McTernan stated that he is more than happy to have Mr. Karon get back with the details the member is asking for to answer his questions.

A member of the public asked if it is true that a discrimination lawsuit was filed against the New Brunswick Parking Authority last year. Mr. Karon stated that he will get back to the member with an answer to that question as well.

A member of the public inquired about updates on the supermarket space, and Mr. Karon stated that they are still negotiating.

A member of the public inquired about the total debt of the Parking Authority. Mr. Rajaratnam stated that the total debt is currently the same amount.

A member of the public inquired about the downtown changes that have been made to accommodate delivery drivers and the drop-off/loading zones. Mr. Karon stated that the changes have made a difference.

A member of the public stated that the City Council approved increasing the Authority's cut of each fine or ticket from \$4 to \$6. The member noted how significant this change is and asked how much more revenue the Authority might receive from this. Mr. Karon stated that it will increase by 50%, and he will get back with more detailed information on that.

MID JERSEY MUNICIPAL JOINT INSURANCE FUND RESOLUTION TO JOIN

WHEREAS, a number of local units have joined together to form the Mid Jersey Municipal Joint Insurance fund ("Fund") as permitted by N.J.S.A. 40A:10-36; and

WHEREAS, the statutes governing the creation and operation of a Joint Insurance Fund contain elaborate restrictions and safeguards concerning the safe and efficient administration of the public interest entrusted to such a Fund; and

WHEREAS, The New Brunswick Parking Authority has determined that membership in the Fund is in the best interest of the local unit; and

WHEREAS, the local unit agrees to be a member of the Fund for a period of three (3) years, effective January 1, 2025, said membership to terminate on January 1, 2028, at 12:01 a.m. standard time; and

WHEREAS, the local unit has never defaulted on claims is self-insured and has not been canceled for nonpayment of insurance premiums for two (2) years prior to this Resolution; and

NOW, **THEREFORE**, **BE IT RESOLVED** by the New Brunswick Parking Authority, in the County of Middlesex and State of New Jersey, as follows:

- 1. The local unit hereby agrees to become a member in the Mid Jersey Municipal Joint Insurance Fund for a period commencing January 1, 2025 and terminating on January 1, 2027, 12:01 a.m., for the purpose of establishing the following types of coverage:
 - A. Workers' Compensation
 - B. Crime and fidelity including excess public official's statutory bond;
 - C. Liability auto, general and employee benefits;
 - D. Non-owned aircraft liability;

E.	Police	professional	l liability;

F. Property damage including automobile physical damage and boiler and machinery;

After the expiration of the initial period, participation may be canceled or extended in accordance with the Bylaws of the Fund.

- 2. For the purposes of contribution of sums into the Fund to be designated for administrative costs and claims, the New Brunswick Parking Authority hereby agrees to obtain the types of coverage from the Fund as are set forth in Section 1 of this Resolution and the Indemnity and Trust Agreement to be signed by the participants.
- 3. The Bylaws of the Mid Jersey Municipal Joint Insurance Fund, attached hereto, are hereby adopted and approved.
- 4. The Executive Director is hereby authorized and directed to execute a written agreement signifying application for membership in the Fund and to execute such other agreements, including but not limited to the Indemnity and Trust Agreement in order to implement membership by this local government agency in the Fund according to its terms.
