A member of the public asked for an update on the former supermarket space at Wellness Plaza, including when the county would start paying rent. Mr. McTernan stated that a resolution was on the meeting agenda to start the demolition of that space so that the county could begin its renovation and begin paying rent.

NEW BRUNSWICK PARKING AUTHORITY RESOLUTION TO AWARD CONTRACT FOR WELLNESS PLAZA INTERIOR DEMOLITION

Whereas, it is deemed necessary and in the best interests of the Commissioners of the Parking Authority of the City of New Brunswick, in the County of Middlesex, upon the basis of public advertisement and competitive bids, to award a contract for interior demolition services of the former supermarket space within Wellness Plaza; and

Whereas, public bids were opened on October 5, 2022 in response to the bid specification of the NBPA; and

Whereas, Two Brothers Contracting, Inc., having an office at 11 Vreeland Avenue, Totowa, NJ 07512, with a bid in the amount of \$662,400.00 (including \$100,000.00 reserve) is the lowest responsive, qualifying bidder for the Wellness Plaza interior demolition project; and

Whereas, Two Brothers Contracting, Inc. provided the New Brunswick Parking Authority with a letter dated December 1, 2022, and on file with the Authority, holding its bid through January 31, 2023; and

Whereas, the Commissioners of the Parking Authority of the City of New Brunswick desire to award a contract for the Wellness Plaza interior demolition project to the lowest responsive bidder.

Now Therefore Be It Resolved, that the New Brunswick Parking Authority award a contract for the Wellness Plaza former supermarket space interior demolition project, as a result of an advertised public bid, pursuant to NJSA 40A:11 et seq. of the Local Public Contract Law of the State of New Jersey, to Two Brothers Contracting, Inc., the lowest responsive bidder for the demolition project.

Be It Further Resolved, that in order to effectuate the objectives of this resolution, the Board of Commissioners of the Parking Authority of the City of New

Brunswick, authorize the Chairman or Executive Director of the Authority to award said contract to Two Brothers Contracting, Inc.

Be It Further Resolved, that said award of contract pursuant to this resolution is contingent upon the NBPA having sufficient funds and the Chief Financial Officer of the Authority certifying that there are sufficient funds budgeted by the Authority for the services.
